T. 32 S. R 3 W. 1/4 Corner to Section 25 only.

Found - 50" Fir bears S. 77° W. 52 links mkd: "1/4 S 25 BT" with open face, scribes in good condition

36" Fir bears N. 21° W. 84 links mkd: "1/4 S 25 BT" with open face, scribes in good condition.

Set - 2" x 30" galvanized iron pipe with Brass Cap stamped:

T 32 S R3 W 1/4 R2W S25 1968 OLS 536

From the Pipe Monument, the Original BT's are:
42" Fir bears N. 21° W. 55.4 feet mkd: 1/4 S 25 BT.
69" Fir bears S. 77° W. 34.3 feet mkd: 1/4 S 25 BT.

Placed BT tags on all bearing trees and facing the monument.

T. 32 S. R. 3 W. Section Corner to Sections 29, 30, 31 and 32. Found - Corner stone, 18 x 8 x 8, firmly set mkd: 1 notch on South and 5 on East.

Original 15", now 27" Douglas Fir, N. 51° E. 30.4 feet, shows good scar.

Original 36", now 47" Douglas Fir, S. 41° E. 19.1 feet, shows good scar.

Original 30", now 38" Cedar, S. 16° W. 35.6 feet, scribe visible.

Original 30", now 34" Yellow Pine, N. 30° W. 21.8 feet, scribe visible. Set - Brass Cap at Cor. mkd:
