

# **ENGINEER'S CERTIFICATE**

I, Bryce W. Townley, a duly registered Engineer of the State of Oregon, being first duly sworn, do hereby certify that I have correctly surveyed and marked with proper monuments as provided by law, the tract of land herein shown and the said plat is a correct representation of the same and the following is an accurate description of the boundary lines:

Commencing at a 3/4" Iron Pipe being the Corner of Donation Land Claims 70, 71, 72 and 73, Sec. 25, T<sup>38</sup> S, R. 1 W, W.M. Jackson County, thence North 34° 42' West, 14.15 feet to a Concrete Monument; thence North 46° 27' 10" West, 210.32 feet, to a 2" Iron Pipe being the Initial Point of Beginning; thence South 43° 20' 50" West, 30.00 feet to the Centerline of Old Pacific Highway; thence along said centerline South 46° 27' 10" East 297.21 feet; thence along the arc of a 818.51 foot radius curve to the left 80.26 feet (L.C. = S 49° 15' 43" E, 80.23 feet) to the intersection with the northwesterly Boundary of Hyde Park Subdivision; thence along said boundary North 35° 24' East, 31.13 feet to a 2" Iron Pipe, thence continuing on said Boundary North 32° 01' 00" East, 311.56 feet; thence North 57° 59' 00" West, 147.00 feet; thence South 32° 01' 00" West, 150.00 feet; thence North 58° 24' 54" West, 197.60 feet; thence South 43° 20' 50" West, 120.00 feet to the Initial Point of Beginning.

SURVEY FOR: Jeanne Vaughan

PURPOSE: To survey and monument lot boundaries for  
Mountain Vista Subdivision.

LOCATION: Southwest Quarter, Section 25, Township 38  
South, Range 1 West, Willamette Meridian,  
Jackson County, Oregon.

PROCEDURE: Found D.L.C. corner common to claims 70, 71,  
72 & 73, and monuments per R.S. 4188.

Found monuments per Recorded Plat of Hyde  
Park Subdivision, and used as basis of bearing.

Using said monuments, then surveyed and monu-  
mented lot boundaries as shown on Mountain  
Vista Subdivision Plat.
