

SURVEY NARRATIVE TO COMPLY WITH OR.S. 209.250

SURVEY FOR:

Bob Bellamy

Rogue River Drive Eagle Point, Oregon

LOCATION:

A PORTION OF SECTIONS 28, & 29, TOWNSHIP 34 SOUTH, RANGE 1 WEST, WILLAMETTE MERIDIAN, JACKSON COUNTY, OREGON.

PURPOSE:

TO ESTABLISH THE NORTH BOUNDARY OF THE PARCEL AS SHOWN

ON ATTACHED MAP.

PROCEDURE:

A TRAVERSE WAS RUN FROM THE FOUND 5/8" IRON PIN ON ROGUE RIVER DRIVE TO A POINT 500 FT. SOUTH OF THE FOUND SECTION CORNER COMMON TO SECTIONS 20, 21, 28 & 29, THENCE ON TO A MEANDER POINT ON THE WEST BANK OF THE ROGUE RIVER. THE MEANDER POINT WAS RE-ESTABLISHED FROM ADJACENT MEANDER STAKES FOUND FROM PREVIOUS SURVEY NO. 6205. THE LOCATION OF MONUMENT SET BY THE SURVEY WAS JOINTLY APPROVED BY BOTH PRINCIPAL LANDHOLDERS WHOSE LAND WAS THEREBY DIVIDED.

MONUMENTS SET ARE SHOWN ON ATTACHED MAP & ARE 3/4" IRON PIPE 3' LONG.

LOCATION:

A PORTION OF SECTIONS 21, 28, & 29, TOWNSHIP 34 SOUTH, RAMGE'I WEST, WILLAMENTE MERIDIAN, JACKSON COUNTY, OREGON.

PURPOSE:

TO DIVIDE THE PARCEL OF LAND AS SHOWN ON ATTACHED MAPS.

PROCEDURE:

THE TWO POINTS THAT DIVIDE THE PARCEL 1. 500' SOUTH OF FOUND SECTION CORNER

20, 21, 28, 29 A POINT PREVIOUSLY USED AS A MEANDER POINT

ON THE WEST BANK OF THE ROQUE RIVER.
THIS POINT WAS ESTABLISHED FROM STAKES FOUND
ON ADJACENT KEAMDER POINTS UP & DOWN STREAM.

MOTUMENTS SET ARE SHOWN ON ATTACHED MAPS & ARE 3/4" IRON PIPE 3' LONG.
