This corner had been searched for without success on several occasions by Forest Service personnel and County Surveyor Deputies. A proportional position was computed from survey control and the following evidence was recovered:



At each of the above corners evidence was found indicating the presence of a corner. Each corner had a stone monument marked with an 'X' and the letters SLM (Section Line Marker) with various reference trees. At each corner where the evidence was found I was unable to locate any evidence traceable to the original establishment of this corner. These corners were tied to my random traverse and evaluated by proportional measurement.

Several steps were taken in an attempt to prove or disprove the evidence found at each respective corner with the following conclusions:

- The stone monuments found were of sufficient size and purposely marked to indicate the presence of a corner.
- 2. Sufficient witness trees had been marked to reference the stones.
- The portional position calculation closely verifys the position of each corner.
- A move to the portional position would cause a dog leg distortion to the bearings of the lines running north and south from the corner.
- 5. Conversation with adjacent landowners reflects the use of the stone monuments for the respective corner for over 30 years. Records at Boise Cascade Corporation were observed and indicate these corners were used to establish cutting lines in several directions from these corners indicating the corners had been accepted as a local point of control for many years.
- I located blazed lines leading to both corners. These lines varied in age by growth ring count from 17 to 60 plus years.
- No other eivdence could be recovered to disprove the corners.

In view of these facts I elected to accept the positions of the found stones and monument corner positions as follows:

Township corner common to Section 36, Township 37 South, Range 3 East and Section 31, Township 37 South, Range 4 East and Section 1, Township 38 South, Range 3 East and Section 6, Township 38 South, Range 4 East, Willamette Meridian.
