


PRIVATE ROAD CENTERLINE DESCRIPTION

A strip of land 60 feet in width, 30 feet either side of the following described centerline, located in Section 15, Township 35 South, Range 4 West of the Willamette Meridian, Jackson County, Oregon being more particularly described as follows: Beginning at a 5/8 inch diameter iron rod on the southeasterly right of way line of East Evans Creek Road, said point bears North 53°54'45" West of and 243.30 feet distant from the Southeast Corner of the Northwest Quarter of said Section 15; thence South 68°20'45" East, 98.16. feet; thence North 82°09'23" East, 139.49 feet; thence South 45°24'37" East, 136.03 feet; thence North 89° 43' 29" East, 296.28 feet; thence South 00°04' 19" East, 165.0 feet; thence North 89°43'29" East, 968.82 feet and there terminating.
