Commencing at the Northeast corner of Donation Land Claim NO. 45, Section 3, Township 36 South, Range 1 West of the Willamette Meridian, Jackson County, Oregon; thence North 0°43'12" West, 1179.20 ft. to the Initial Point, being a 2 in. x 36 in. iron pipe at the Northwest corner of Butte Crest Subdivision Unit No. 2; thence North 0°05'10" West, 165.19 ft; thence South 69°01'40" West (record S.69°02'30"W.) 362.00 ft; thence North 82°00' West, 252.49 ft; thence North 456.52 ft; thence North 67°25'20" East, 320.79 ft; thence North 63°46'50" East, 309.68 ft; thence North 58°30'40" East, 189.19 ft; thence North 73°36'30"East, 93.17 ft; thence North 69°02'15" East, 52.30 ft; thence South 0°01' West, 858.53 ft; thence South 4°00' West, 80.00 ft. to a point on the Northerly line of said Subdivision; thence North 88°20'20" West, 169.56 ft; thence North 88°47'10" West, 109.99 ft. to the Initial Point. PRECEDENCE OF Survey:

At the initial point, being identical to the NW. cor. of Butte Crest Sub-d. No. 2, found a $5/8 \times 30$ in. iron pin, this was replaced with a 2 in. x 36 in. iron pipe, 6 ins. deep.

At the NE. cor. of Lot 23 of Unit No. 2, found a 5/8 x 24 in. iron which was replaces with a $5/8 \times 30$ in. iron pin.

At the NE. cor. of Lot 14 in Unit No. 2, found the original corner. A tie was made to a 2 in. pipe found at the NE. corner of DLC 45. (this varies slightly with computed tie from Unit No. 2).
