

Survey to Locate the Boundaries of the Preston V. Cheney Property in the NWI/4 NEI/4 (Govt. Lot 2) of Section 5, T36S R4W, W.M., Jackson Co., Oregon

Narrative description to comply with Par. 209.250, O.R.S.

for: Preston V. Cheney, Box 171, Julian, California 92036

Purpose: As stated above

Procedure: The Jackson County Surveyor's records of reestablished corners, and Survey Nos. 1733, 6067, 6335, 3358, 3548, and 3954 were researched and studied for possible information. The last 3 of the above surveys, by R.E. No. 5604, were particularly important because they represented successive partitionings of the Carl Anderson property. Lying westerly of and adjoining the Cheney property. The Cheney parcel was wiso sold by Anderson, being unsurveyed on the east (40 ty line) boundry. My survey began by traversing Southerly from the Northeast corner of Section 5, to the North I/I6 corner (by Survey No. 1733); thence westerly along the Fielder Creek Road, tying to a 5/8 inch iron rod set on the north side by Survey No. 3954 for the southeast corner of Allen; thence continuing westerly and tying to 5/8 inch iron rods set by Survey No. 6335 on the north-south center line of Section 5, one of these being the center north I/16 corner; thence northerly to the North Quarter Corner; thence easterly to the East 1/16 corner, checking measurements en route, between 5/8 inch iron rods set by Survey Nos. 3358, 3548, and 3954; thence southerly to one of my previous traverse hubs in the Fielder Creek Road. Then, also using information from and provided by my ties to Survey Nos. 1733 and 6335, the Subdivision of the NEI/4 of Section 5 was computed. It appeared that there was a hiatus in the record versus on-theground distances between monuments found, on the north line of Govt. Lot 2. This resulted in a possible narrowing of the width at the north end of the Cheney property. A study the sequence and apparent intent of deeds for properties lying westerly of Cheney's indicated: (1) That of all the properties sold by Anderson, Cheney's was the junior conveyance, and, (2) The distance on the north side of Allen's property was fied to and called from the monument on the east side of Carmel Drive. The 5/8 Inch from rod found at the purported north corner for Allen and Cheney was accepted therefore, though it resulted in a shortening of Cheney's called-for width, by 20.73 feet. Cheney's true east and west lines were then surveyed, monumented as shown on my map, and marked with lath, red flagging and red-painted blazes. Unpainted recent blazes, not on the true lines, were also noted. Survey equipment used included a Kern I second theodolite and "Beetle" No. 1000 for electronic distance measurements. Corner data is as follows:

Corner of Sections 32, 33, 4 & 5, found 2" G.I.Pipe and B.T's per Jackson County Surveyor's 1953 Reestab:

22" Cedar S 46 3/4°W 55.8', face healed 9" W. Oak N I2 1/2°W 93.7', face healed

17" Y. Pine N 48 1/2°E 45.6', face healed

CN 1/16 corner by Survey No. 6335, found 5/8" from rod and:
