


LEGEND:

LOCATION:

A PORTION OF LOTS 6, 7 AND 8 OF COTTAGE ADDITION TO THE CITY OF MEDFORD, BEING IN THE NORTHEAST ONE-QUARTER (1/4) OF SECTION 24, TOWNSHIP 37 SOUTH, RANGE 2 WEST, WILLAMETTE MERIDIAN, JACKSON

COUNTY, OREGON.

PURPOSE:

TO MONUMENT PARCEL OWNED BY CLIENT.

PROCEDURE:

AFTER TRAVERSING TO THE VARIOUS CONTROL POINTS AS SHOWN ON THE ATTACHED MAP AND RESEARCHING THE LEGAL DESCRIPTIONS OF RECORD, I DISCOVERED TWO MAJOR ITEMS WHICH SHOULD BE NOTED.

THE DESCRIPTIONS OF THE PROPERTIES
NORTH AND SOUTH OF MANZANITA BETWEEN
COURT STREET AND BOARDMAN LEAVE AN
AREA OF 50 FEET FOR MANZANITA STREET.
HOWEVER THE LOCATION OF THIS STREET
IS DIFFERENT IN THIS AREA THAN ANYTHING
I COULD FIND ON PREVIOUS SURVEYS AND
WITH CITY RECORDS. ALL OTHER DATA
INDICATES A 50 FOOT WIDE ROAD WITH
20 FEET ON THE NORTH SIDE AND 30 FEET
ON THE SOUTH SIDE. PROPERTY DESCRIPTIONS,
AS SHOWN ON THIS MAP, DO NOT REFLECT

SAID PREVIOUS LOCATION.

ANOTHER ITEM THAT SHOWED UP WAS THAT THE PROPERTIES ON THE WEST SIDE OF BOARDMAN DO NOT ABUT THE WEST LINE OF BOARDMAN BY A DISTANCE OF FIVE FEET.
