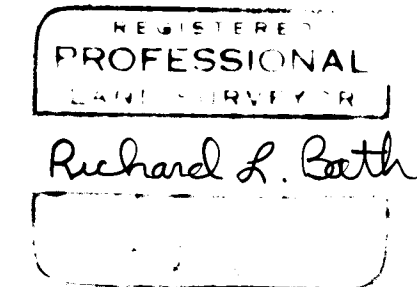

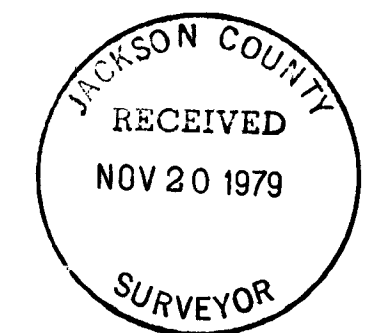

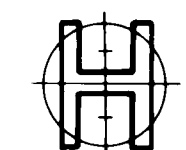

CREATION OF PRIVATE ROAD

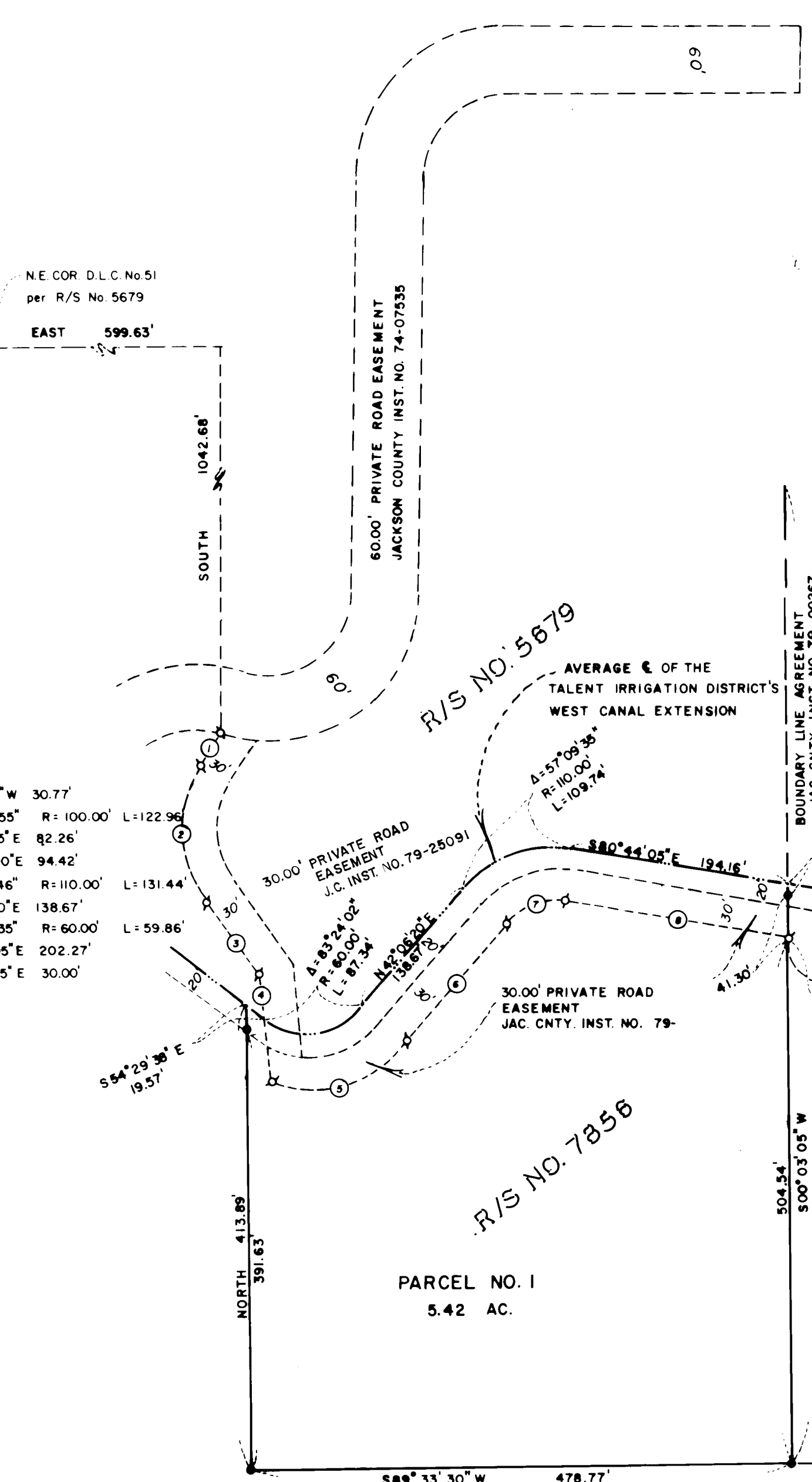
