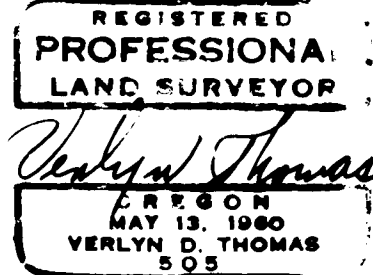

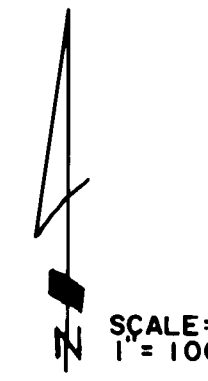

PURPOSE: To monument a private road and prepare a final plat according
to preliminary plat furnished by client.

PROCEDURE: Established private road from terminus of Citadel Road as mon-
umented by Recorded Survey No. 4406.
