SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250 OREGON REVISED STATUTES

LOCATION:

Northwest one-quarter (1/4) of Section 3, Township 36 South, Range 1 West, Willamette Meridian, City of Eagle Point, Jackson County,

PURPOSE:

To survey, monument, and comply with all current subdivision regulations for the proper resubdivision of Sarah Park

PROCEDURE: The boundary of Sarah Park was originally monumented per Survey No. 6776 by this office. Thomas H. Burton, Land Surveyor, used this monumented boundary to subdivide the subject tract into Sarah Park. When it was decided to resubdivide Sarah Park, verification of monuments became necessary. Additional ties to the Southwest corner of Donation Land Claim No. 45 and the Initial Point of Youngs Addition were made and the resulting bearing between these two monuments is South 89° 59' 01" East rather than North 89° 58' 20" East. Inspection of the original computations performed for Survey No. 6776 found an error and confirmed the bearing South 89° 59' 01" East. Since Thomas H. Burton used our monuments for control on the North line of Sarah Park, this means that the Initial Point should theoretically have been set 0.10 feet North of the title line and the Northeast corner of Sarah Park was found at 0.61 feet North of the title line.

The 2 inch iron pipe set for the Initial Point of Sarah Park was actually found to be on the true title line and held for the Initial Point of the resubdivision. At the request of Robert Wiegand, City Engineer, the top of the 2 inch iron pipe was driven to 6 inches below the surface of the ground.

The remainder of all monuments on the North line of Sarah Park were removed and the North line of the resubdivision is monumented to show the correct alignment of the title line.

Resubdivided and monumented the new lots as shown on the plat.




