

SURVEY NARRATIVE

SURVEY in Southeast Quarter of Section 8, Township 35 South, Range 4 West of the Willamette Meridian, Jackson County, Oregon.

SURVEY FOR: Woodrow Owings

PURPOSE OF SURVEY: To create three parcels and a private road from two existing parcels.

PROCEDURE: I began the survey at a 5/8" iron rod shown as the Southeast corner of Parcel 3 on Survey # 5108. I then traversed the perimeter of the land shown on said Survey # 5108 and found substantial deviations from the record.

I then occupy the SE Section corner of Sec. 8, sight and measure to the East Quarter corner and set a concrete nail, in W. Evans Creek Rd., to mark the location of the South 1/16th corner. From last said point I measure Westerly to the SE 1/16th corner; then Southerly to the East 1/16th corner; then Easterly to the SE corner of Sec. 8.

I then monument the entire parcel in accordance with the description provided then divided same into three parcels as shown on the plat. Location of monuments found and set are shown on the accompanying plat. I then monument an easement to provide access to the three parcels. Construction of the private road is complete as of this writing and the improvements are within the marked area.
