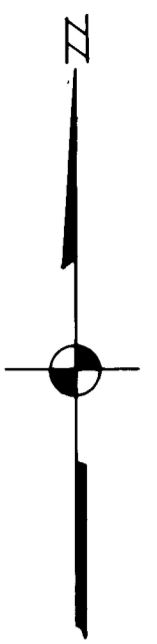


MAJOR LAND PARTITION

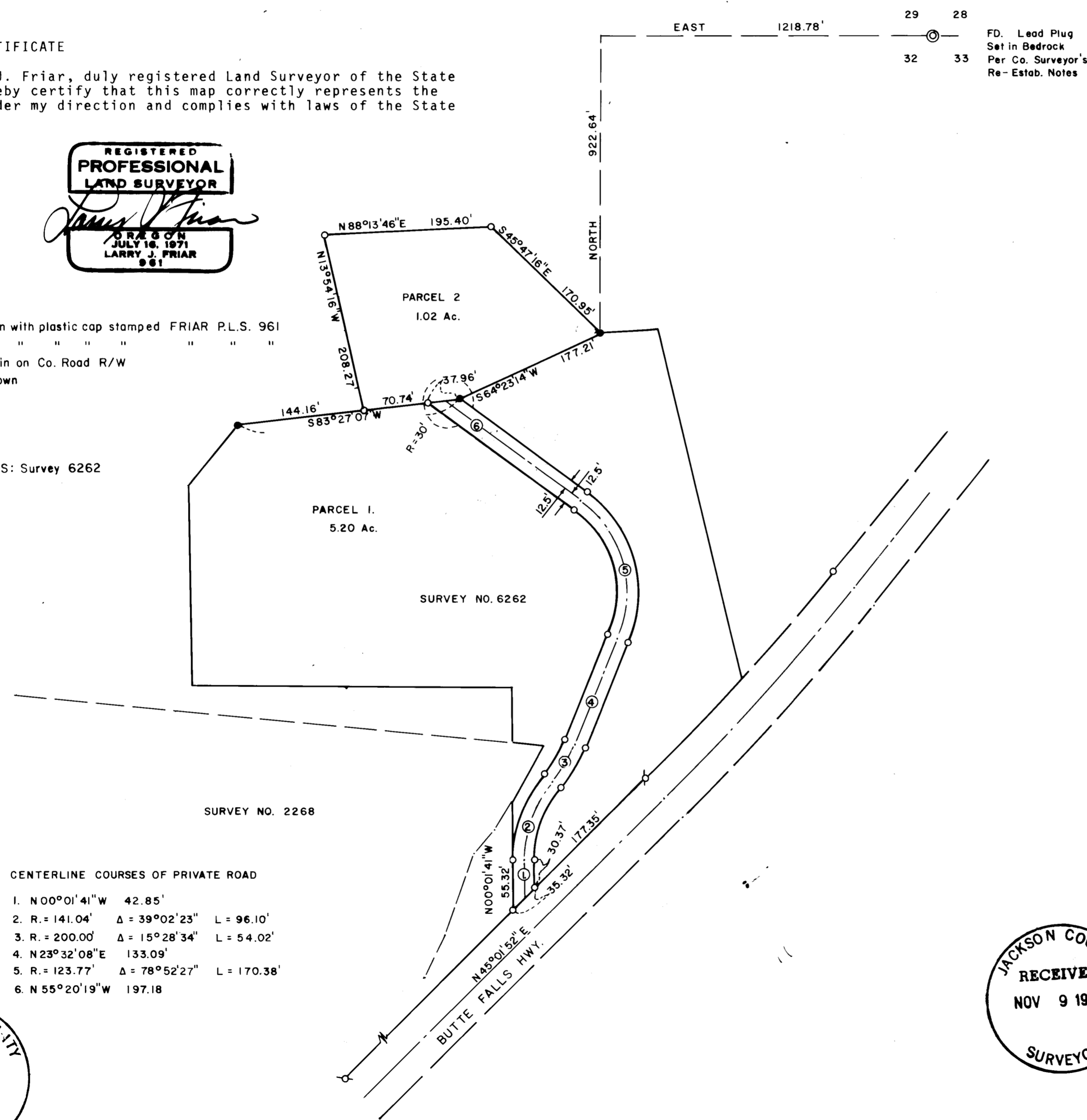

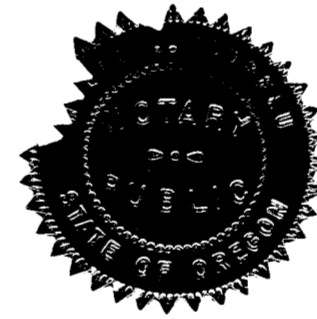
