Also, the flag portion of Lots eight (8) and nine (9) may be utilized for placement and maintenance of public utilities in conjunction with driveways serving each lot. Public and private emergency vehicles shall have the right of ingress and egress over and across those strips of land shown hereon as "PRIVATE ROADS". This subdivision shall be subject to public utility and irrigation easements, existing and as shown hereon. Lots one (1), two (2), three (3), four (4), five (5), six (6), seven (7) and eight (8) shall have an equal right of ingress and egress over and across that "PRIVATE ROAD" which abutts or is a part of said lots. of America. The retracement was based upon the location of this monument with the deed record bearing being oriented to the retraced results found between Highway Station 122+98.85 and 131+75.24. The retracement of the relocated Green Springs Highway, in the vicinity of the "Old Siskiyou Highway", was also established by comparing data with found monumentation along said highway. As heretofore related, it was felt that to relocate the line as originally set out and described in Parcel No. 2 of Tract No. 311-A per Volume 463, page 115 of the Deed Records of Jackson County, Oregon, the best remaining evidence was and is the monumentation utilized and shown on the accompanying survey map. The alignment of the "Old Siskiyou Highway" was established by splitting the existing asphaltic road, as no apparent monumentation could be found. Re: Pacific Higway, Siskiyou Section, Map F-5-6.

The proposed building sites on Lots 3, 4 and 8 were required to be shown graphically upon the final map by the Senior Soil Scientist of Jackson County. Also, the graphical location of each proposed driveway for Lots 2, 3 and 4 were required to be shown by said Soil Scientist. The graphical locations of the power line and coaxial cable was deemed in the best interest of the public to warn them of the apparent easements and probable useage restrictions for each parcel encumbered thereby. The location of the underground telephone line (COAXIAL CABLE) as shown on the accompanying plat is approximate only. The true centerline of said easement, is the cable itself, and no locations should be scaled from this plat. Contact the "TOLL WIRE CHIEF" of the Pacific Telephone and Telegraph Company, 509 SW Oak Street, Portland, Oregon, before any digging or construction activity is undertaken.

The section corners, quarter section corner and Donation Land Claim corner were correlated to this survey by previous ties made while conducting other surveys within the general area.


To subdivide a portion of the Dauenhauer ownership into five (5) acre, or larger, parcels of land per clients request.


PROCEDURE:


Once again the Southerly boundary line of Donation Land Claim No. 45 was searched for with negative results. Two (2) or three (3) prior surveys, by this firm and this survey has yet to reveal the monumented Southeast corner of Donation Land Claim N. 45. Therefore for the purpose of this survey the South line of Donation Land Claim No. 45 was established government record distance, Northerly of, the quarter corner common to Sections 31 and 32 which was re-established by this firm and shown on Recorded Survey No. 5503. This Southerly boundary line falls some four (4) feet, more or less, Southerly of an existing East-West fence. This position will not create a problem with the neighbor to the North, as far as lines of occupation are concerned. Along the Westerly portion of the Dauenhauer ownership, there exists a random wire fence. This has been considered by the client as well as his neighbors, to be the property line between their respective properties. This of course does not fit the section line, within reason, at all. Therefore, the client was advised to secure boundary line agreements which he has done. The monuments called for in said boundary line agreements, were set and are to be used in a common role as the line agreed to by the respective landowners and the Westerly boundary of the proposed Sunny Oaks Subdivision.

The right of way of the relocated Green Springs Highway (Hwy. No. 66) (in part) was secured by the United States of America as set forth in Volume 463, page 115 and Volume 440, page 131 of the Deed Records of Jackson County, Oregon. The United States of America then Quitclaimed unto the State of Oregon, said right of way, as set forth in Volume 601, page 48 of the Deed Records of Jackson County, Oregon. In retracing the right of way of said relocated Green Springs Highway, some minor differences were found to exist between the values given on Oregon State Highway Drawing No. 8B-7-7 and the actual monuments found. It was determined that in most cases the monuments would be held as controlling. However, in the case of retracing the Southwesterly boundary line of Parcel No. of Tract No. 311-A per Volume 463, page 115 of the Deed Records of Jackson County, Oregon, it was decided that due to the lack of any monumentation or evidence of the Southeast corner of Donation Land Claim No. 45, calculations from previous surveys would be utilized to try and retrace the deed record so as to verify the position of the monument found in the Southwesterly right of way at State Highway Station 103+98.85; considering the vast amount of variables encountered in said calculations, the location of said monument did not seem unreasonable; Therefore, said pin is considered to be the best remaining evidence as to where the boundary line of said Parcel No. 1 was originally established and conveyed to the United States
