Description of corner evidence found:

At the corner point I found a standard Bureau of Land Management brass cap monument marked as shown in the corner diagram above; from which the following references:

An 8-inch diameter madrone bears S63° 32'E, 12.0 feet dist., with fragments of scribe marks visible.

A 7-inch diameter fir bears SO7° 34'E, 14.20 feet dist., with scribe marks visible on a partially healed blaze.

A 32-inch diameter pine bears SO5° 43'W, 17.67 feet dist., with a healed blaze.

A 9-inch diameter fir bears S18 53'W, 14.98 feet dist., with a partially healed blaze.

A broken, decayed fir stump of undetermined size bears N69° 42'W, 17.10 feet dist., no scribe marks visible.

A 10-inch diameter pine bears N52° 56'W, 19.50 feet dist., with a healed blaze.

A 15-inch diameter fir snag bears N45° 15'E, 32.66 feet dist., with a healed blaze.

A 31-inch diameter pine snag bears N56° 24'E, 35.52 feet dist., with a healed blaze.
