

PURPOSE:

To create a Minor Partition according to preliminary approval granted by the Jackson County Planning Department.

PROCEDURE:

The easterly line of the subject property was established from survey monuments previously established by this office in performing Survey No. 6459.

No attempt was made to establish the true northerly or southerly boundaries of the subject property as this would require a section break-down, which was not economically feasable for this project.
