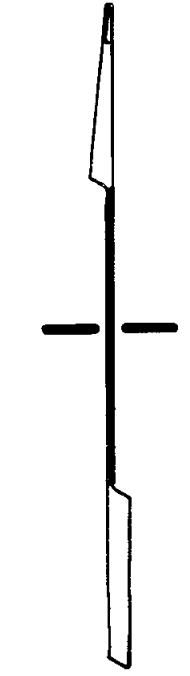


PLAT

PURPOSE: To survey and monument the property of Charles Kilpatrick in  
the W $\frac{1}{2}$  of the W $\frac{1}{2}$  of the SW $\frac{1}{4}$  of S 22 T35S R1W W.M. as recorded  
in Jackson County Deed Book Volume 79\_27985. To survey and  
monument the property of G. D. Devey in the E $\frac{1}{2}$  of the W $\frac{1}{2}$  of  
the SW $\frac{1}{4}$  of S 22 T35S R1W W.M.

BASIS OF BEARING: Recorded Survey 7185

PROCEDURE: I ran a closed traverse survey around the SW $\frac{1}{4}$  of said section 22,  
beginning at the S $\frac{1}{4}$  corner then Northerly to the C $\frac{1}{4}$  corner, then  
Westerly to the W $\frac{1}{2}$  corner, then Southerly to SW corner of S22,  
then Easterly back to the S $\frac{1}{4}$  corner of said S 22. I then tied in  
the Right of Way pins on Crater Lake Hiway.  
I then subdivide said SW $\frac{1}{4}$  section into parcels according to deed  
descriptions and monument clients boundaries as shown on the plat  
to accompany this report.
