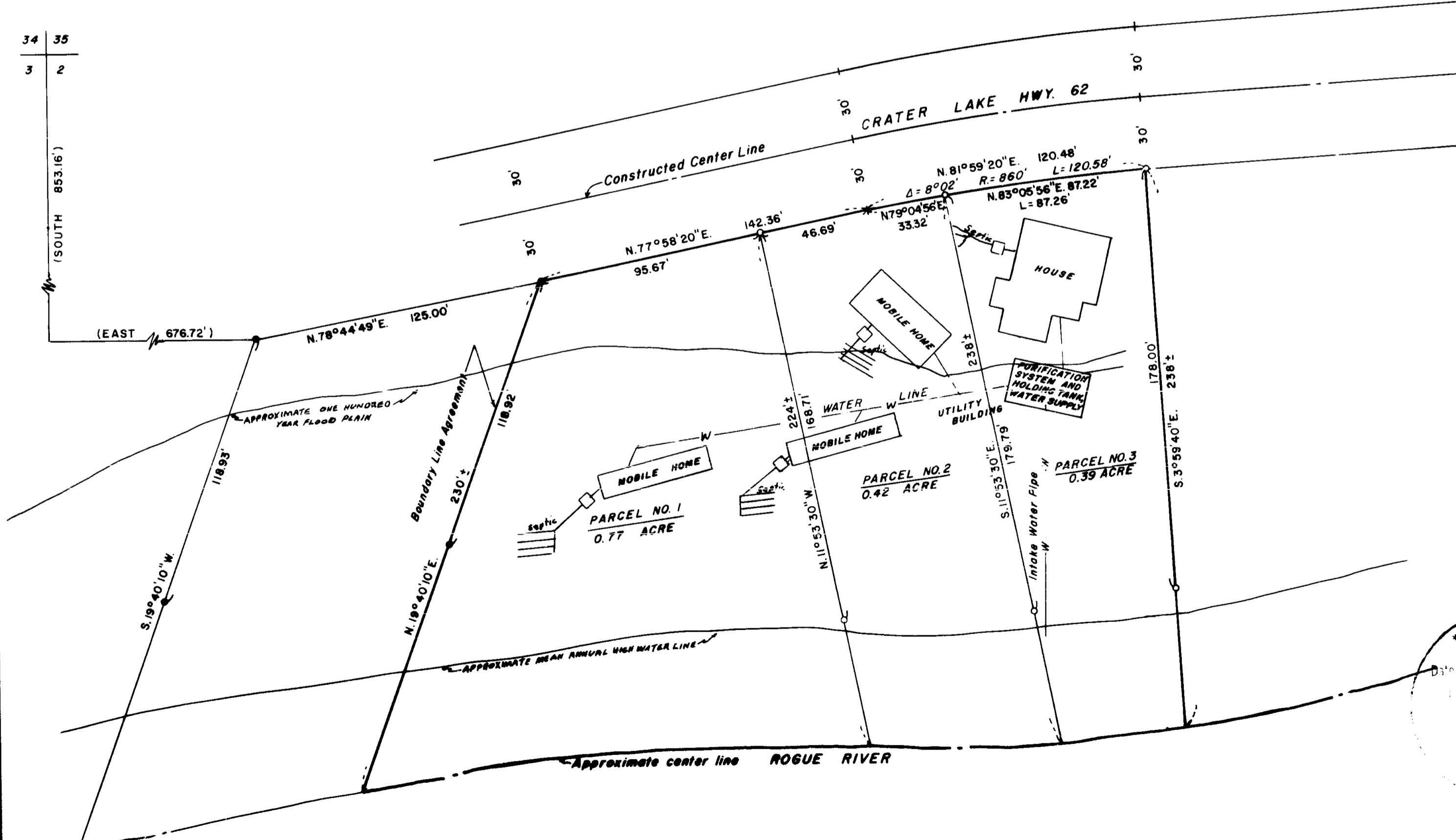
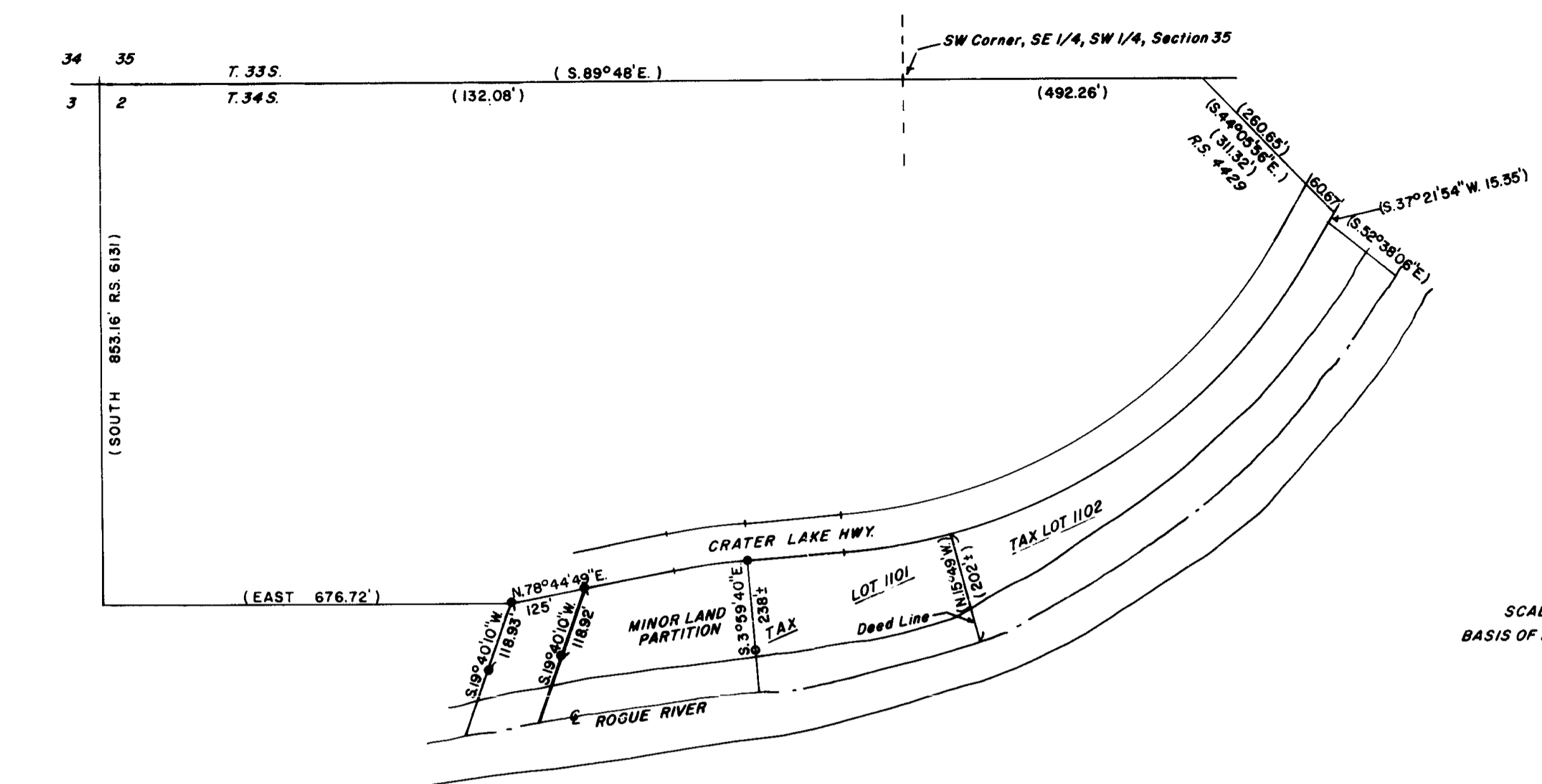

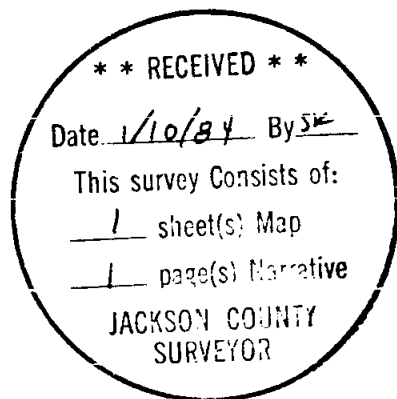

as shown on the accompanying plat.

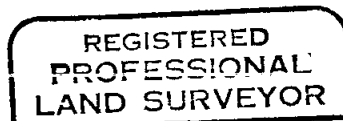
