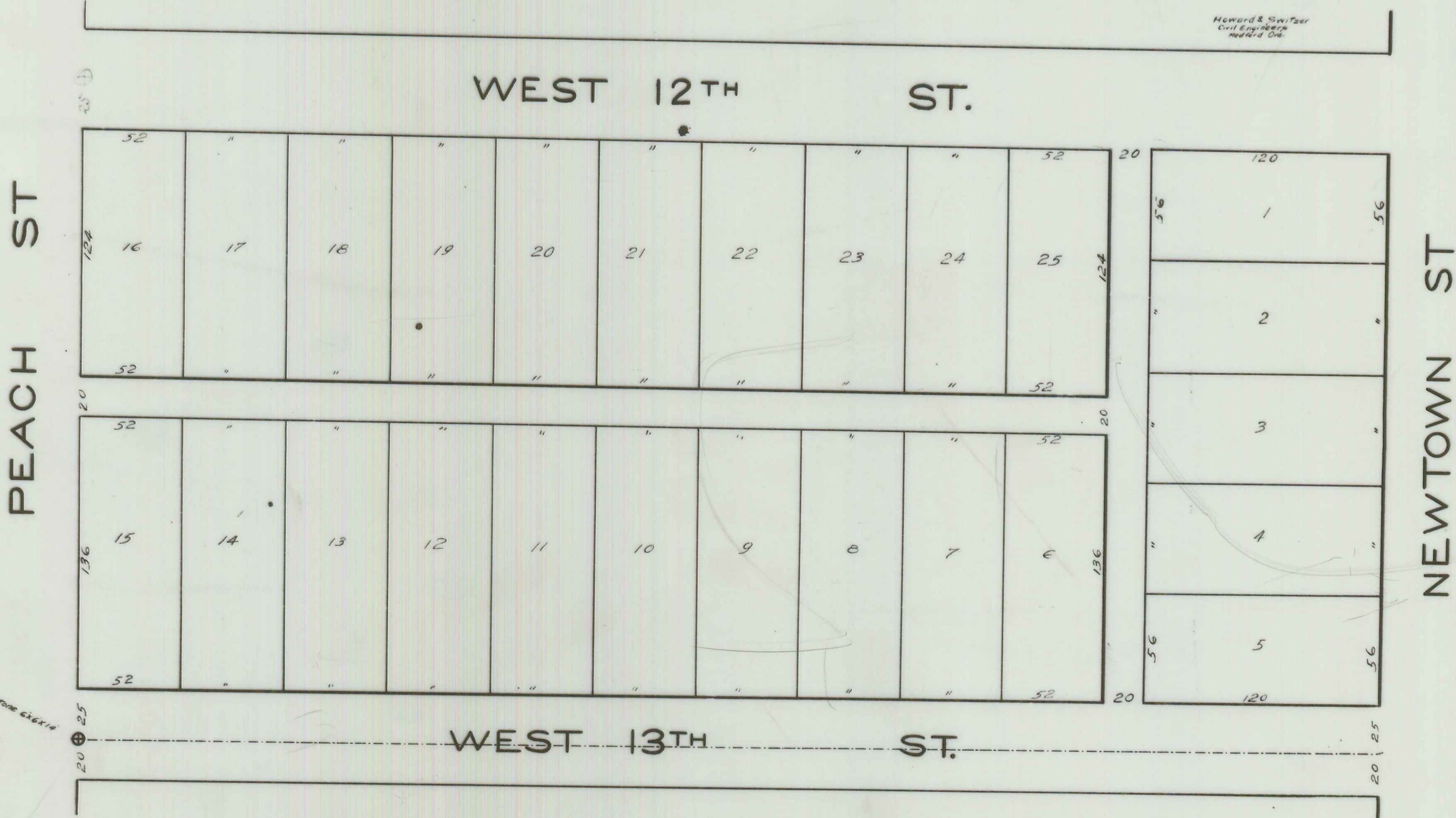


— EMIGS' ADDITION —

DESCRIPTION Subdivision of Lot 2 Block 3 of Barra Addition to Medford Ore. described as follows:— Beginning at the S.W. corner of said Lot on the East side of Peach St. at which point 1 set a sandstone 6"x6"x14" inches below the surface of the ground marked with a cross at the intersection point and from which the 1/4 Sec. corner between Sections 25 and 30 in Twp 37 S. R. 2 W. of W.M. bears 62 5/8 ft. South and 74 8/8 ft. West, and from said corner stone I run thence North 330 ft. to the N.W. corner of said Lot 2, thence East 660 ft. to the West line of Newtown St., thence South along the West line of said Street 330 ft. to the S.E. corner of said Lot, thence West 660 ft. to the place of beginning.
