Description

Commencing at the Quarter Section Corner common to Sections 24 and 25 Township 37 South Range 2 West U.M. and running thence South 29.7 feet to the Northeast Corner or place of beginning; thence West parallel with Jackson Street 532.93 feet to the Northwest Corner; thence South 926.55 ft to the North side of West Second Street or Southwest Corner; thence East along the North side of said Second Street 532.93 feet to the Southeast corner; thence North 927.70 ft to the Northeast Corner or place of beginning.

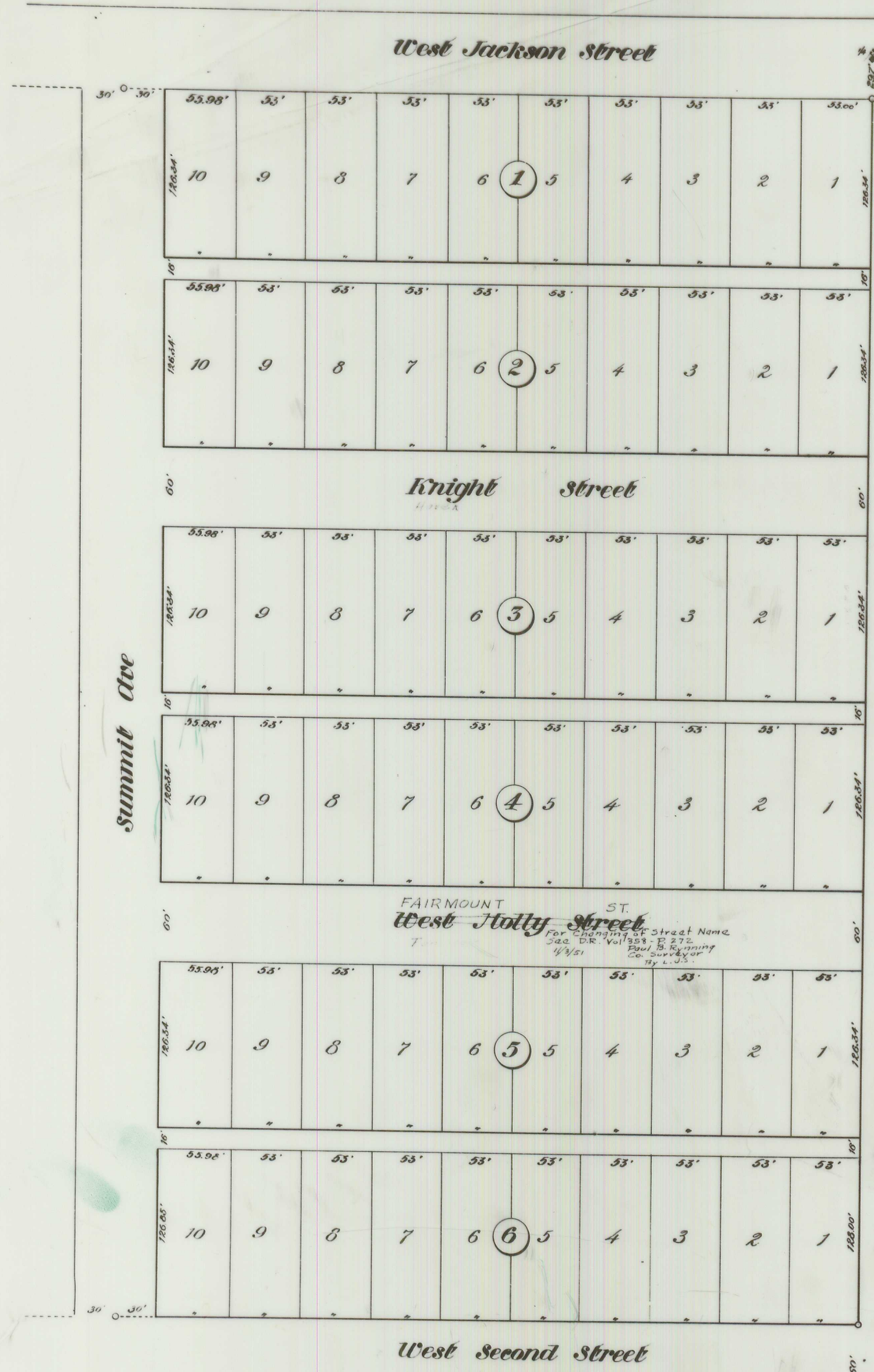
