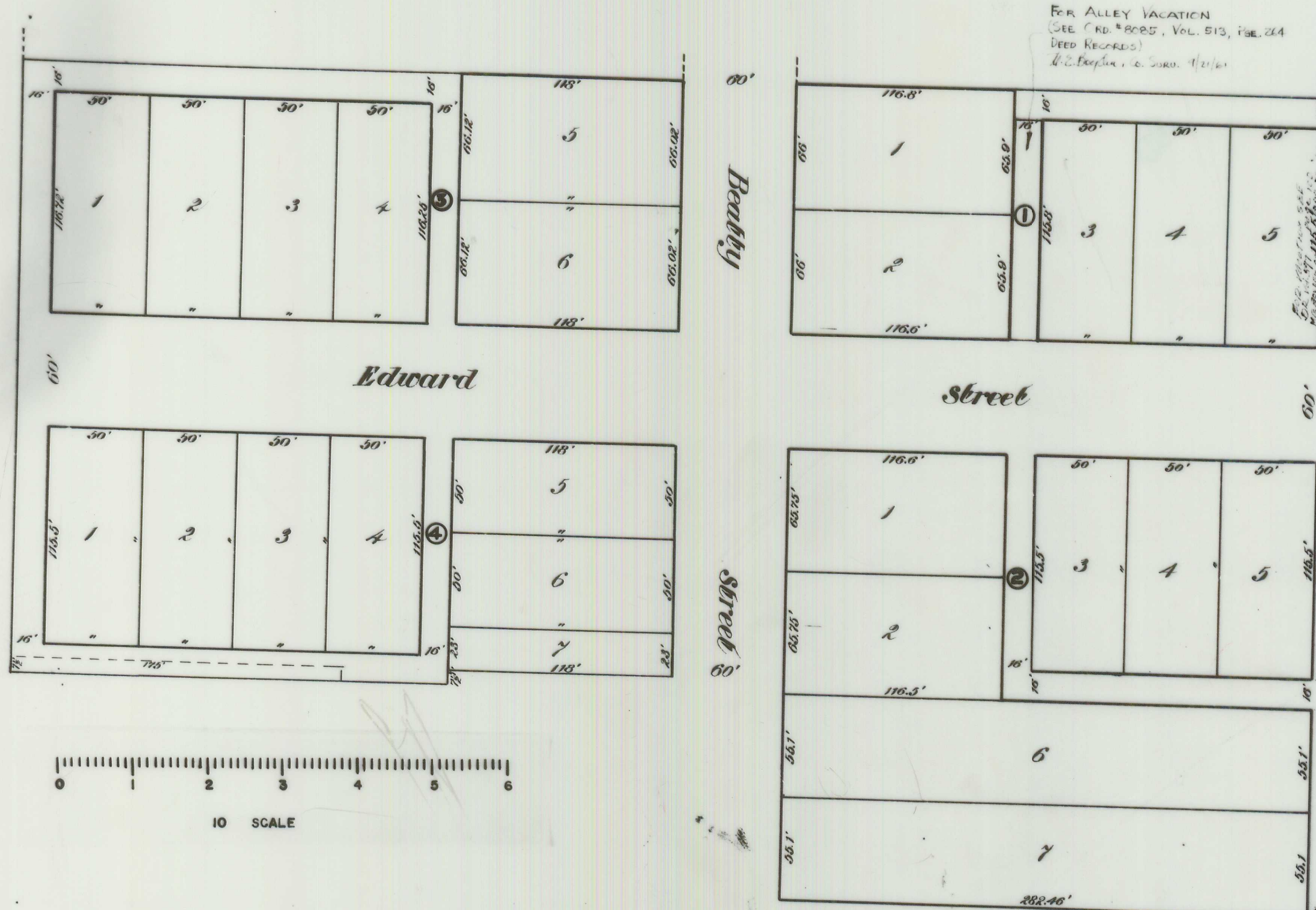


WILDWOOD ADDITION TO THE CITY OF MEDFORD OREGON

Know all men by these presents that I, E.F. Winkler am the owner in fee simple of all the above described land, save and except the south half of the alley as located on the south side of Block No 4, same being 1/2 ft by 175 ft as shown hereon, that I have laid out the same into lots, blocks, streets, and alleys as shown by the map hereon, and that said map is a correct representation of said survey and subdivision, and I do hereby dedicate to the public for public use as highways all of the streets and alleys as shown on the Plat of said tract and I do hereby designate and name the said tract as shown hereon as "Wildwood Addition"
