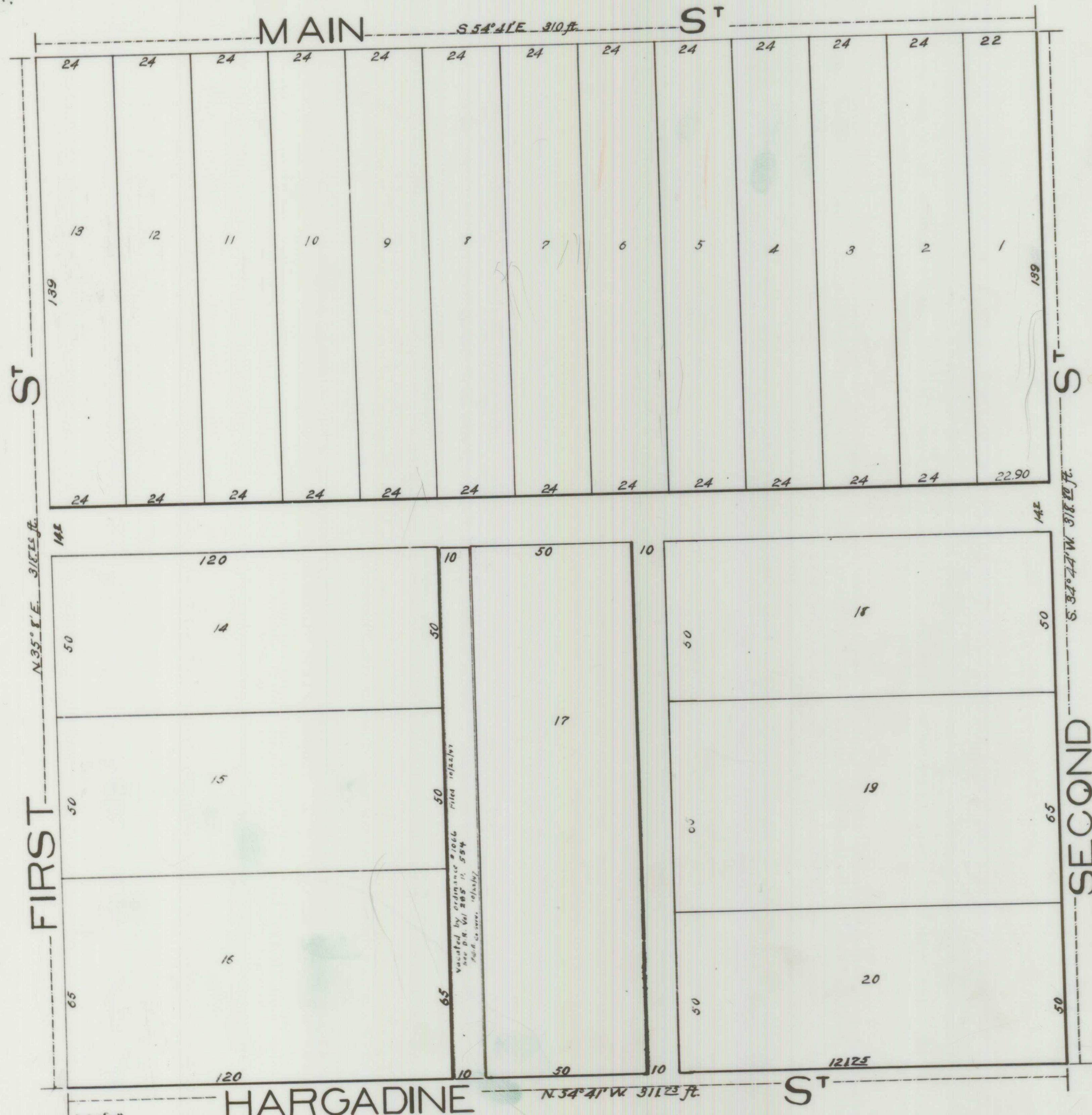

DESCRIPTION OF OUTSIDE BOUNDARIES Beginning at east line of First St and south line of Main St thence S 54° 41' E, along south line of Main St 310 ft to west line of Second St, thence S 34° 41' W, along west line of Second St 318.80 ft to north line of Hargadine St, thence N 54° 41' W, along north line of Hargadine St to east line of First St thence N 35° 1' E, along east line of First St 312.53 ft to Main St the place of beginning.
