**DEDICATION:** Know all Men by these Presents, that we C.H. Whistler and Nannie Whistler, his wife, are the owners in fee simple of the above described land, and that we have subdivided the same into lots, streets and alleys as shown on the map of same, herewith attached, and on which the number and size of the lots and the lengths of all lines are plainly set forth, and we hereby DEDICATE to the public for public highways all of the streets and alleys as show on said map, and we hereby designate the said tract as the "FAIR HEIGHTS ADDITION."
