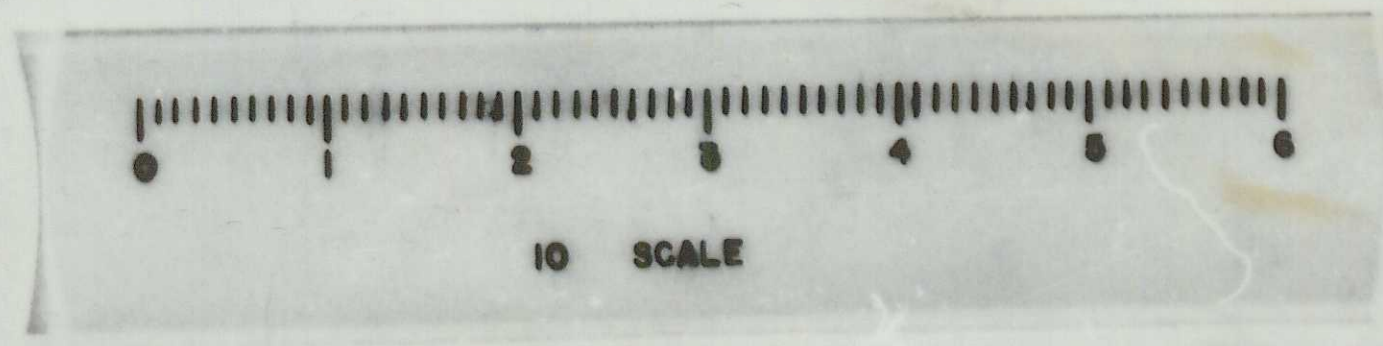


**PLAT

-SURVEYOR'S AFFIDAVIT & DESCRIPTION OF BOUNDARY-

THIS IS TO CERTIFY that I F.H. Walker did on May 6th AD 1910 correctly survey and mark with proper monuments the lands as shown by map hereon, being a part of the city of Ashland, Jackson County, State of Oregon, that said map is a correct representation of said survey as made by me on the ground, and that I planted a 2 in. galvanized Iron pipe 3 ft long 6 in below the surface of the ground at the intersection of the west line of Harrison Street and the North westerly line of Euclid Avenue for place of beginning; thence, for outside boundary of said land, North along the West line of Harrison Street 598.14 feet to the South line of Montana Avenue; thence West along the South line of Montana Avenue 642 feet; thence South 63.75 feet; thence East 605.47 feet to the aforementioned North westerly line of Euclid Avenue; thence N44°46'E along said Northwesterly line, to place of beginning.
