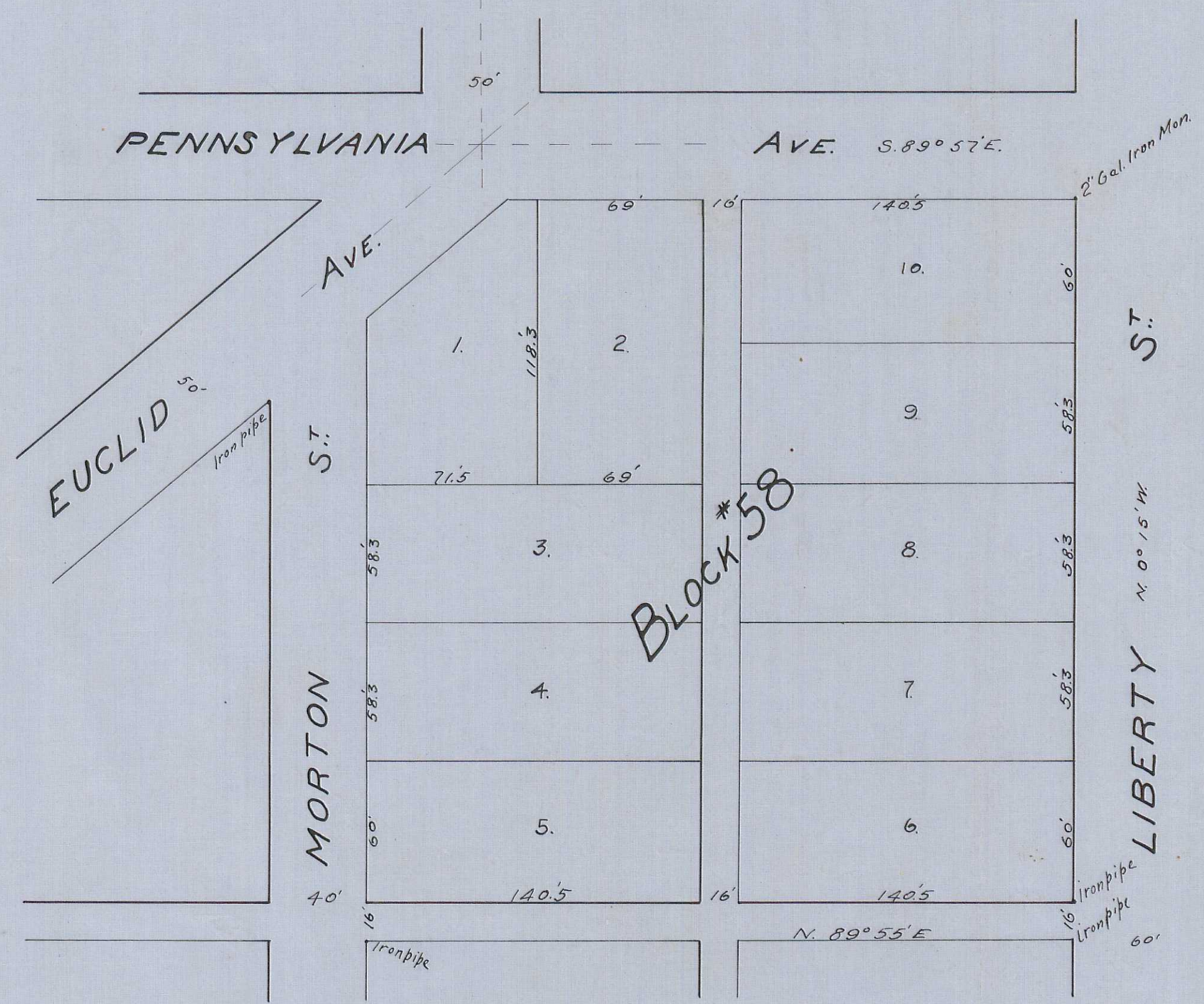


Plat of

SURVEYORS AFFIDAVIT AND DESCRIPTION OF BOUNDARY
 THIS IS TO CERTIFY that I, F.H. WALKER did on Sept. 12th A.D. 1910 correctly survey and mark with proper monuments the lands as shown by map hereon, being a part of the City of Ashland, Jackson County, State of Oregon; that said map is a correct representation of said survey as made by me on the ground, and that I planted a 2 inch galvanized iron pipe 3 ft. long, 6 inches below the surface of the ground at the intersection of the West line of Liberty St and the South line of Pennsylvania Ave. which point is described as being located from the 1/4 cor. of Sec's 9 and 16 as follows: N 89° 59' E from 1/4 cor. 1293', thence N 0° 15' W 956.4 to the place of beginning; thence for outside boundary of said land, S 89° 57' E. 234.6, thence south-westerly along Easterly line of Euclid Ave. to the east line of Morton St, thence S. 0° 15' E, along East line of Morton St 244.9, thence N 89° 55' E. 297' to the W. line of Liberty St, thence N. 0° 15' W. along W. line of Liberty St 294.9 to the place of beginning.
