

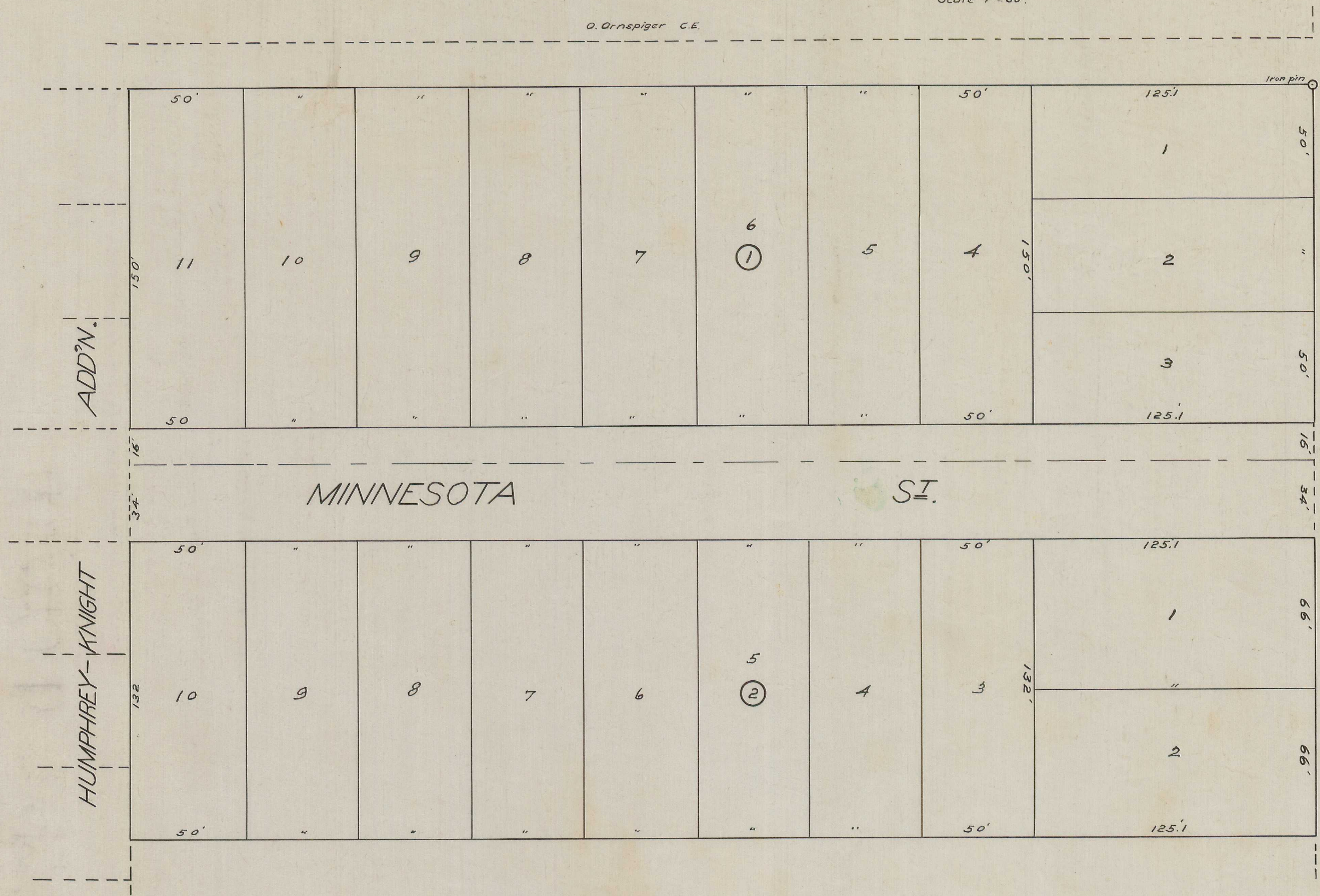
# HUMPHREY-ANDREWS ADDITION

Commencing at the southeast corner of Fruitdale Addition which is 690 feet North and 30 feet West of the south east corner D.C. 42, Township 37 South, Range 1 West, 11th and running thence, South on West line of Roosevelt Ave. 232 feet, thence West 525.1 feet; thence North 322 feet; thence East 525.1 feet to place of beginning.

**Dedication.**
