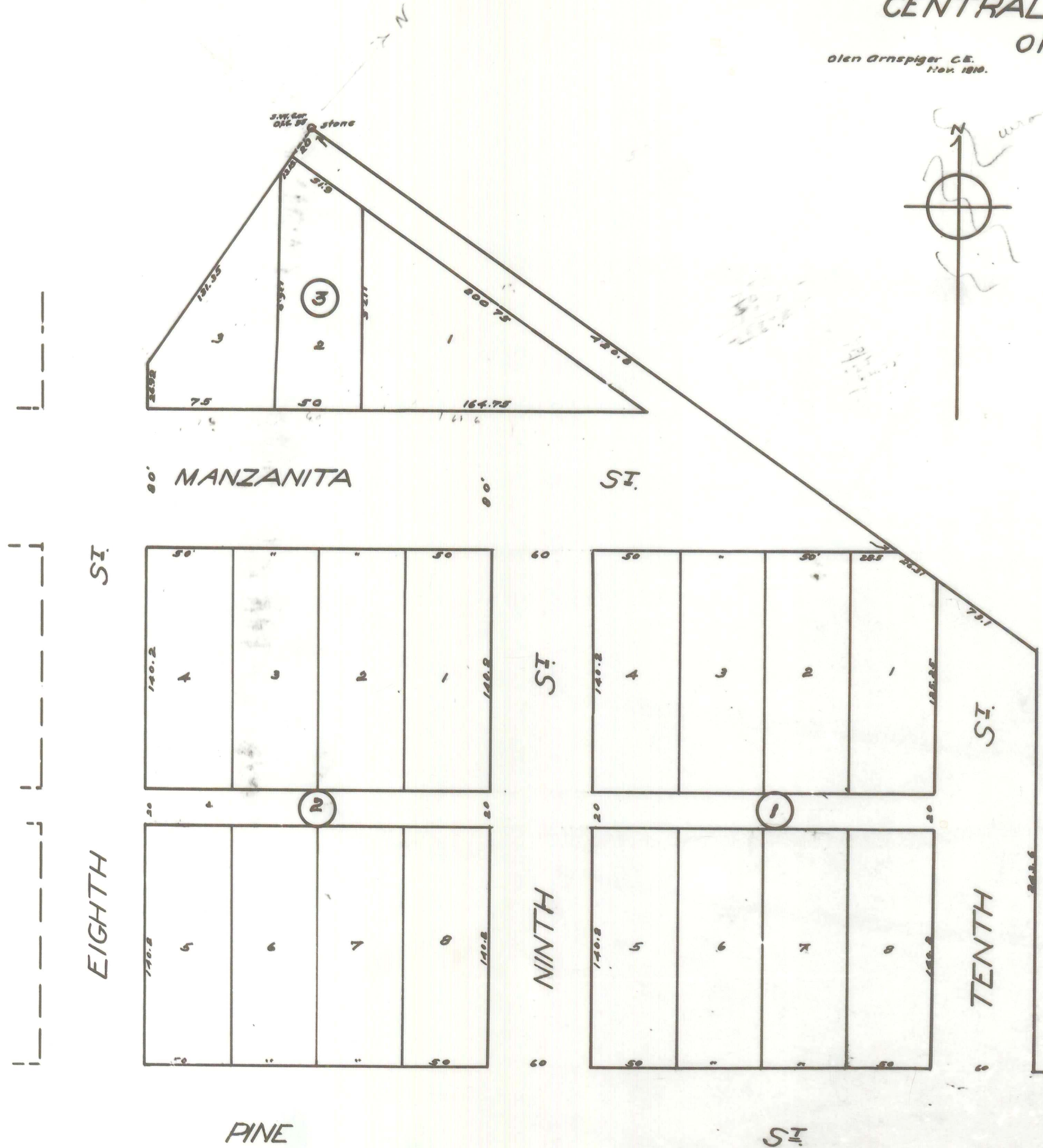


SHIELDS AMENDED ADDITION CENTRAL POINT, OREGON.

Beginning at the South west corner of D.L.C. 755, Township 37-South Range 2 West, W.M., and running thence East on south line of said Claim 520.21 feet; thence South 35° 00' East 243.6 feet; thence South 54° 52' West on North line of Pine Street, 520 feet; thence North 35° 00' West on East line of Eighth St. 407.92 feet; thence North 164.5 feet to the place of beginning.
