

SURVEYORS AFFIDAVIT AND DESCRIPTION OF BOUNDARY
THIS IS TO CERTIFY THAT I H.G. BUTTERFIELD did on Oct. 28-31-1910, correctly survey the lands as shown by map hereon, being a part of Govt. Lot #4 - Sec. 5 T. 39 S. - R. 1 E. W.M.O. in City of Ashland, Jackson County, Oregon. That said map is a correct representation of said survey made by me, and that said survey is tied in to the S.W. Corner of Govt. Lot #4 in Sec. 5 - T. 39 S. - R. 1 E. W.M.O. The outside boundary of this tract is described as follows - From the intersection of the South line of Manzanita St. with the East line of Woolen St. run S. 0° 30' E. - 204 ft, thence S. 22° 32' E. - 235 ft, thence N. 59° 30' E. - 181.9 ft, thence N. 17° 46' W. - 343 ft. to the S. line of Manzanita St. - thence West 148.9 ft to the place of beginning. The initial point of survey is at the S.W. Corner of Tract, where an iron pipe is driven.
