**SURVEYORS AFFIDAVIT AND DESCRIPTION OF BOUNDARY**  
 THIS IS TO CERTIFY that I, F.H. Walker did on Sept. 19-20 AD 1910, correctly survey and mark with proper monuments, the lands as shown by map hereon, being a part of the City of Ashland, Jackson County, State of Oregon, that said map is a correct representation of said survey as made by me on the ground, and that said survey is tied in to the S.M. Cor. of D.L.C. #43-7395. N. 35 E. where there is planted an 8" x 14" sand stone 6" below surface of ground. For the outside boundary description of land platted I describe it as follows:  
 Beginning at a point N 0° 06' E. 30ft distant from the S.M. Cor. of D.L.C. #43 which point is place of beginning of land to be described, thence S. along N. line, 623.8 ft. to the N. line of Mountain Ave, thence North, 600 ft. along N. line of Mountain Ave, to the S. line of 8' Street, thence West, 385 ft. along S. line of 8' Street, thence S. along W. line of Emerick 275 ft. thence N. along N. line, 507 ft. more or less to the W. line of D.L.C. #43, thence South along D.L.C. line 326 ft. to place of beginning.
