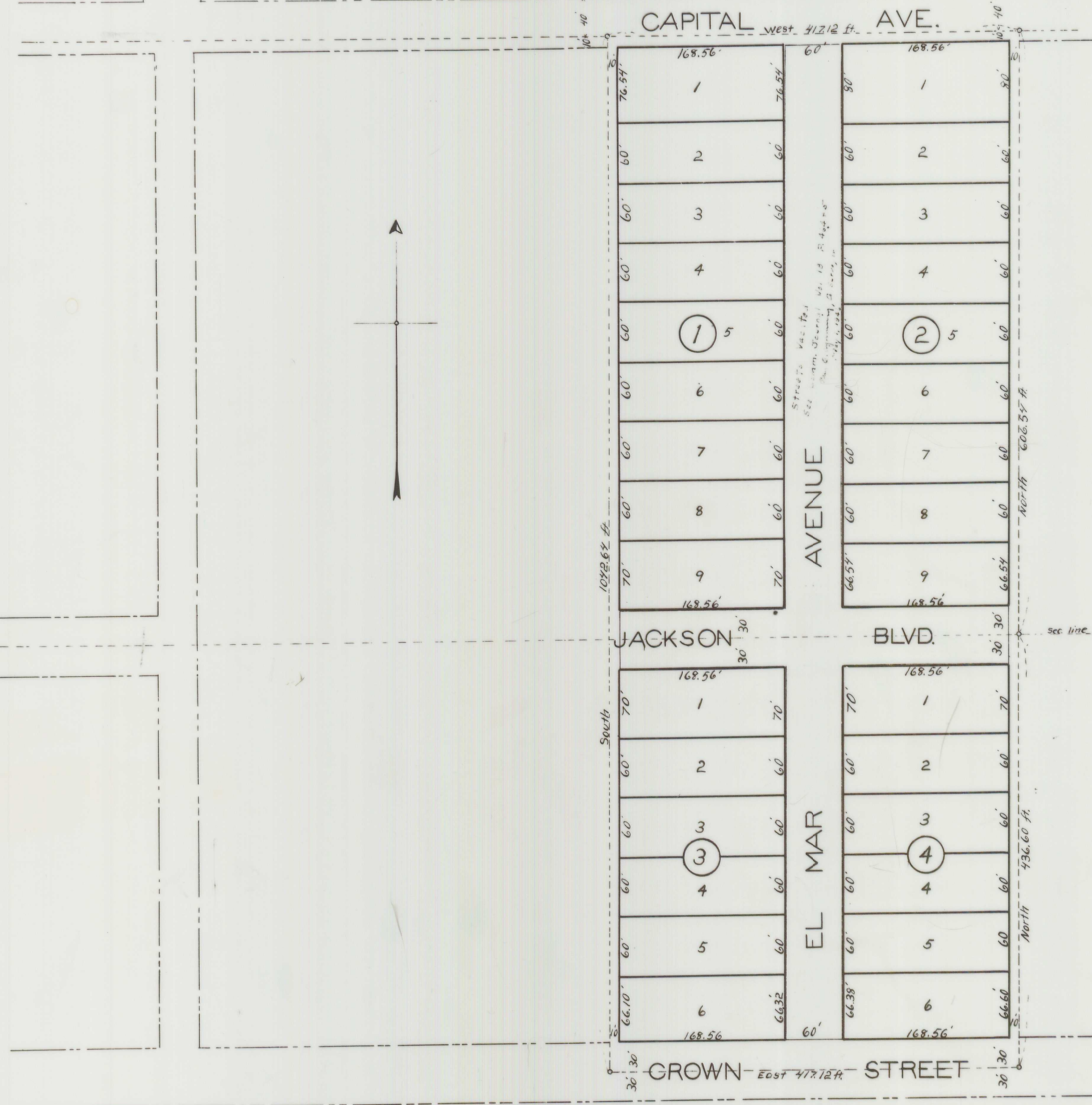


EL MAR ADDITION MEDFORD ORE

Description: Beginning at a point 994.5 feet West of the corner of sections 20, 21, 28 and 29 in Township 37 South, Range No 1 West of Willamette Meridian, and running thence North 66.35 feet; thence East 417.12 feet; thence South 1092.69 feet to the center of Crown Street; thence East 412.17 feet along the center of said street; thence North 436.60 feet to the place of beginning.

Dedication: Know all men by these presents that we Geo. W. Cherry and Anna E. Cherry, his wife, are the owners in fee simple of the above described tract, and that we have laid out the same into lots, blocks, streets and alleys as shown by the map hereon and that said map is a correct representation of said subdivision, and we do hereby dedicate to the public for public use all the streets and alleys shown by the map hereon; and we do hereby designate said plat as the El Mar Addition.
