

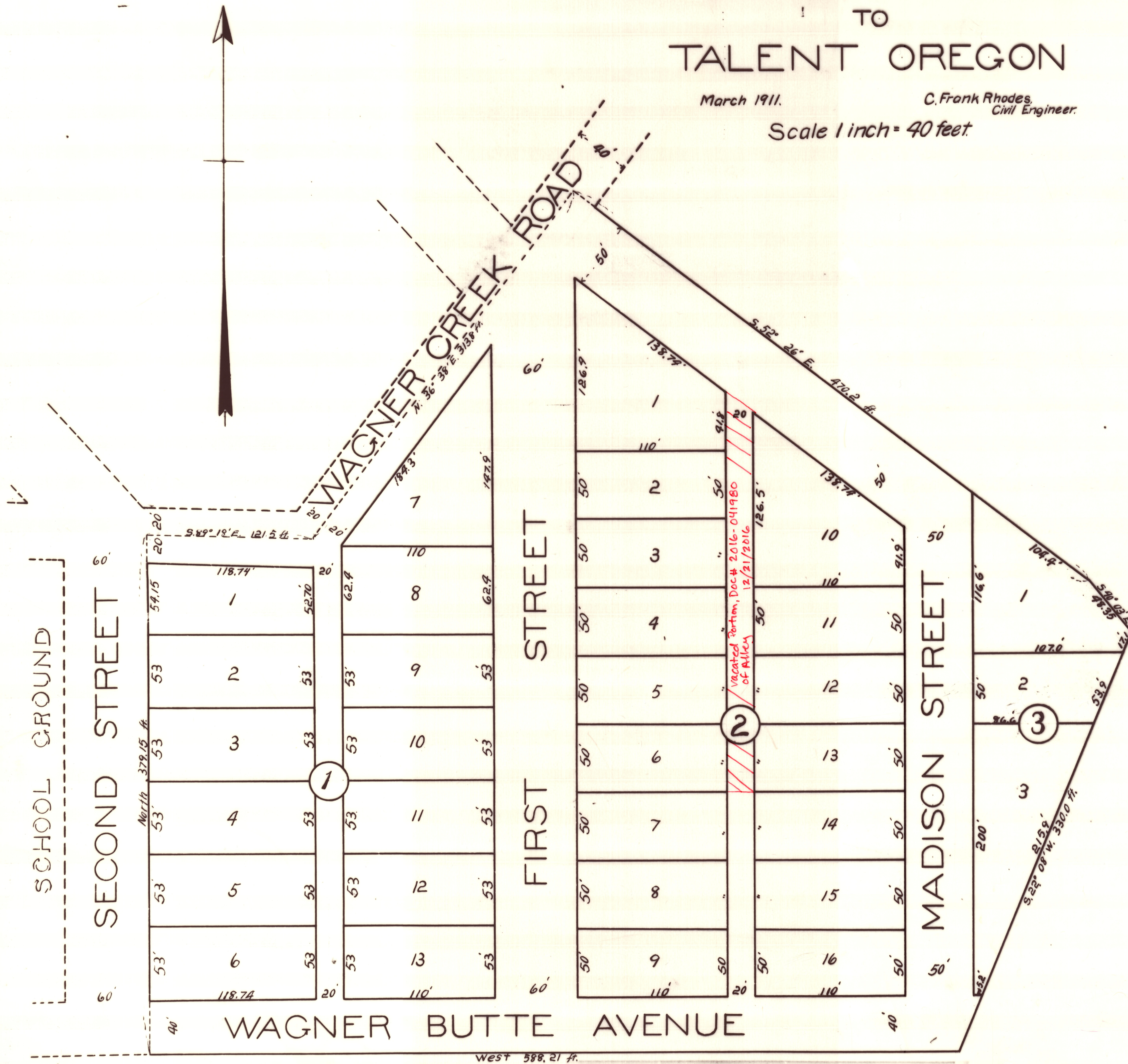
# WAGNER BUTTE ADDITION

## TO TALENT OREGON

March 1911.

Description: Beginning at a point on the corporation boundary marked by a cross on a stone 18 x 10 x 9 ins. set 6 ins. below the surface of the ground from which the S.W. corner of the Jacob Wagner Donation Land Claim No. 67, in Township 38 South, Range 1 West of W.M., bears S. 43° 17' W. 107.5 feet; and running thence North 37° 15' feet to the center of the County road, thence S. 99° 18' E. 121.5 feet along center of said road, thence N. 36° 38' E. 313.5 feet along center of County road, thence S. 52° 26' E. 470.2 feet, thence S. 40° 03' E. 48.39 feet, thence S. 22° 08' W. 330.0 feet to corporation boundary, thence West 588.21 feet to the place of beginning, containing 7.172 acres.

Dedication: Know all men by these presents that we, Martha Elizabeth Rapp, widow, and Frederick Rapp, a single man, both of Jackson County, State of Oregon, are the owners in fee simple of the above described tract of land; that we have laid out the same into Blocks, Lots, Streets and alleys, as shown by the map hereon, and that said map is a correct representation of the survey and subdivision, and that we do hereby dedicate to the Public, for public highways, all the streets and alleys shown on said tract, and we do hereby designate and name the said tract as shown hereon as Wagner Butte Addition to Talent Oregon. Excepting and reserving however the right to maintain a water ditch across Wagner Butte Avenue, the alley between First and Second Streets, and First and Madison Streets.
