**DESCRIPTION.**  
Beginning at a point at the intersection of the S.E. line of Pine Street and the East line of 7<sup>th</sup> Street, said Point being 5.72'-10" E. 50 ft. from the monument at the intersection of the above named Streets; thence N 54° 42' E. 570.50 ft.; thence South 44° 50' ft.; thence S 79° 20' W. 351.38' to the East line of 7<sup>th</sup> St.; thence N 35° 18' W. 219.59 ft. on said East line to the point of beginning.
