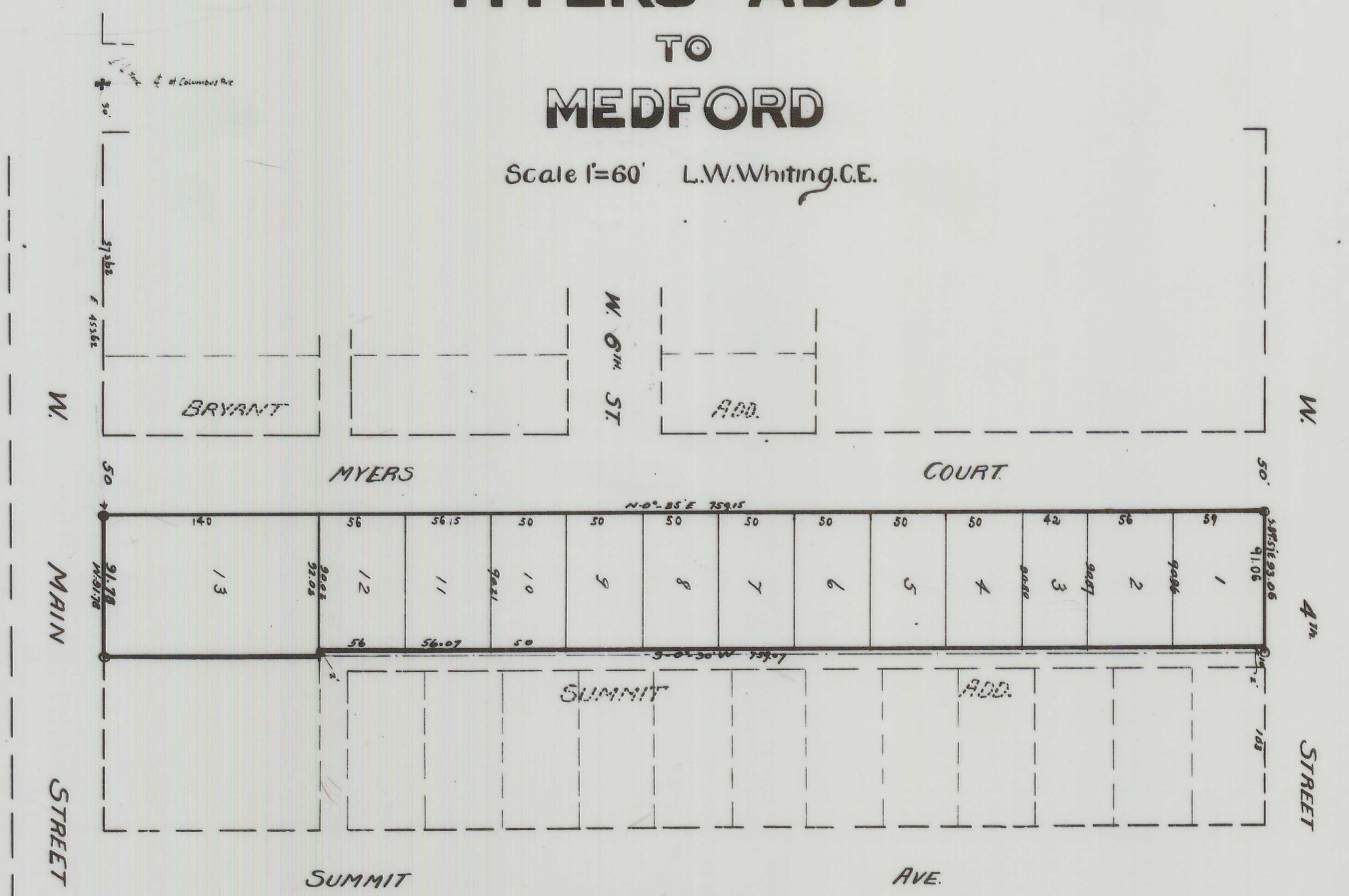


# MYERS ADD.

**DESCRIPTION**  
 Beginning at an Iron Pin situated on the North line of W Main Street and 453.62 ft East of the SE corner of the SW 1/4 of the NW 1/4 of Section 25, T37S, R2W, W.M., thence N 0° 25' E 759.15 ft. to the south line of 4th Street, thence S 29° 57' E 93.06', thence S 0° 30' W 759.07 ft. to the North line of W Main Street, thence W 91.78 ft. to the point of Beginning.

**DEDICATION**  
 Know all men by these presents that we the undersigned are owners in fee simple of the above described tract of land as shown hereon and that we have subdivided the same into lots and Alley as shown and that we hereby DEDICATE the Alley to the public for public purposes and we hereby DESIGNATE said Tract as the MYERS ADDITION to Medford Oregon.
