Said beginning bears N89°52'W 2120 feet and S0°11'W 50 feet from the section corner common to sections 3-10-15 and 16 T39S, R1E W.M. - Thence S89°52'E 540 feet to west line of Roca Streets, thence S0°11'W 640 feet to north line of Fern Street; thence N89°52'W 540 feet to east line of Mountain Avenue thence N0°1'E 640 feet to place of beginning.
