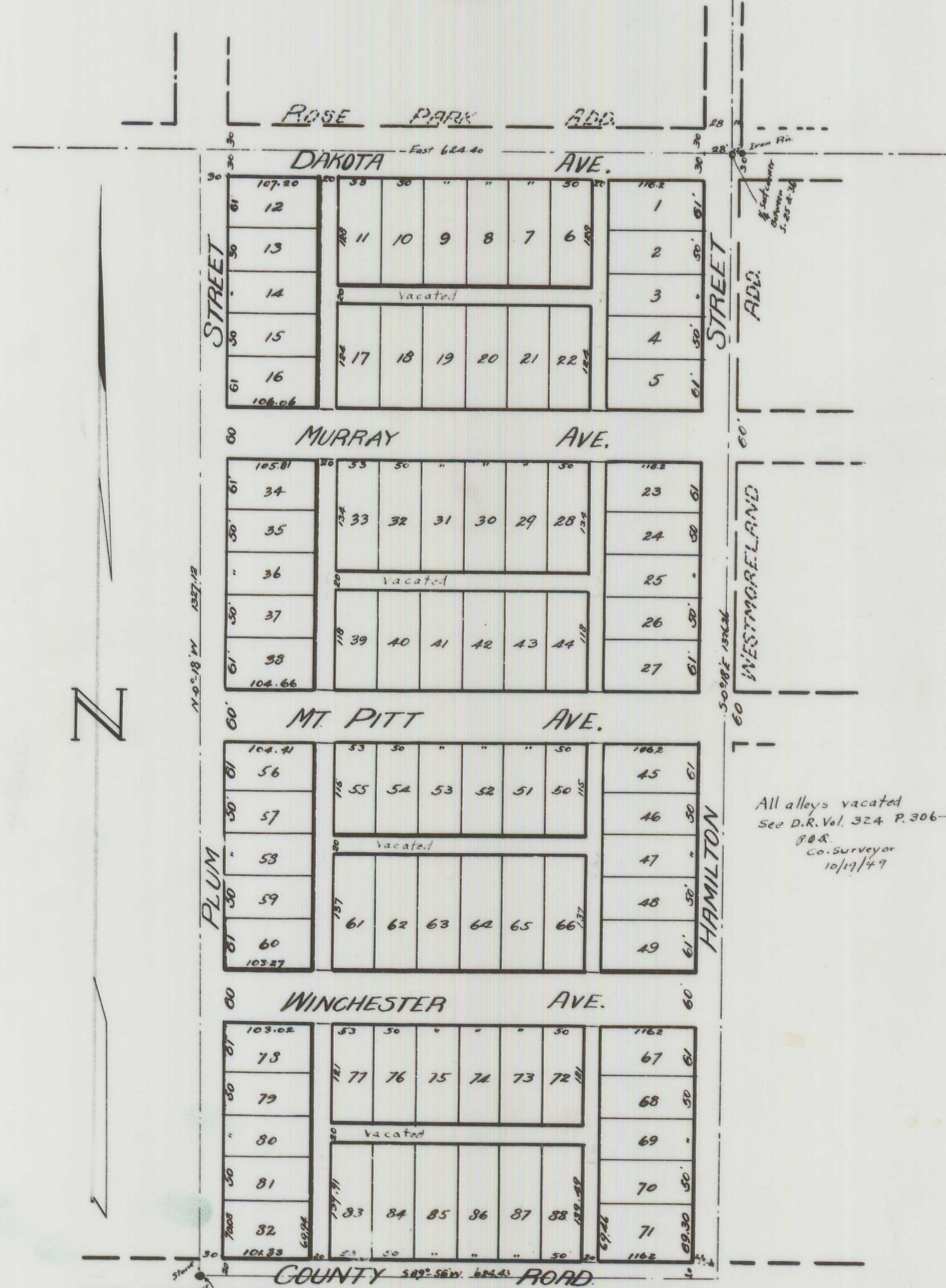


# WINCHESTER PLACE ADDITION TO THE CITY OF MEDFORD.

Beginning at the NW Corner of D.R. 347, 375, R. 2 W, W.M., thence N 0° 15' W 1327.12 ft. thence East on the Section line 624.4 ft. to the 1/4 Corner between Sect 25 & 36 thence S 0° 18' E 1326.26 ft.; thence S 89° 56' W 624.43 ft. to the point of Beginning.
