



SURVEYORS AFFIDAVIT AND DESCRIPTION OF BOUNDARY.
 This is to certify that I, F.H. Walker did on Sept. 13-14 AD. 1911 correctly survey and stake out the lands as shown by map hereon, being a part of the City of Talent, Jackson County State of Oregon; that said map is a correct representation of said survey as made by me on the ground; and that said survey is tied in to the N.E. corner of D.L.C. #64, T.38S. - R.1W. of W.M. where there is planted a 2" Galvanized iron pipe.
 The location and outside boundary description of land platted is as follows
 Beginning at the N.E. Corner of D.L.C. #64 and running thence South along East line of D.L.C. #64 a distance of 344.52 ft and thence S. 73° 30' W. a distance of 593.5 ft to a point which is the place of beginning of description of land platted - Thence continuing S. 73° 30' W. a distance of 7497 ft; thence S. 37° 18' W. a distance of 251.5 ft more or less to an intersection with the Northern side line of County Road; thence S. 52° 42' E. along said side line of County Road a distance of 410 ft; thence at rt angles N. 37° 18' E. a distance of 312 ft.; thence N. 32° 42' W. at rt angles a distance of 365.71 ft more or less to the place of beginning
