



SURVEYORS AFFIDAVIT AND DESCRIPTION OF BOUNDARY.
This is to certify that I F.H.Walker did on Sept. 13-14 AD 1911 correctly survey and stake out the lands as shown by map hereon, being a part of the City of Talent, Jackson County State of Oregon; that said map is a correct representation of said survey as made by me on the ground, and that said survey is tied in to the N.E. Corner of D.L.C. #64, T.38 S. - R. 1 W of M.M. where there is planted a 2" Galvanized iron pipe.

The location and outside boundary description of land platted is as follows:
Beginning at the N.E.
