

Field Notes.

Bounding at a point on the North-easterly line of the Co Wagon
Road extending along the North-easterly side of and adjoining the Town of Medford in
Jackson Co. Or. situated S. 28° E. 351 ft from the point of intersection of said North-easterly
line of said Co. Wagon Road, with the South-easterly line of East 7th Street in said Town
of Medford, and from said point running thence South 28° East along said North-easterly
line of said Co. Road 430.8 feet, thence N. 54° 30' E. 200 ft. more or less to the center chan-
nel of Bear Creek; thence North-westerly along said channel of said creek to a point
situate N. 54° 30' E. of the place of beginning, thence S. 54° 30' W. 200 ft. more or less to the
place of beginning.
