


MAP OF

The Ashland Woolen Mills Tract is apart of the South half of Donation Land Claim No. Forty (40), in Township Thirty-nine (39) South of Range No. One (1) East of the Willamette Meridian, and is situate in the City of Ashland County of Jackson, State of Oregon, and is bounded and described as follows, to-wit: Beginning at the point of intersection of the North line of Main St. with the West line of Water Street, in said City of Ashland, from which point the South East corner of said South half of Donation Land Claim No. 40 bears S. 32° 56' E. 1932 feet distant. Thence N. 23° 30' E. 711.7 feet to the South line of Factory Street, Thence N. 64° 40' W. along the south line of Factory Street, 293.5 feet to the East line of Helman Street, Thence S. 25° W. along the East line of Helman Street 495 feet to the North line of Main Street. Thence S. 30° 36' E. along the North line of Main Street 381.5 feet to place of beginning.

Know All Men By These Presents.

That we W. H. Atkinson and Eugenia L. Atkinson his wife; Jacob Wagner and Ellen H. Wagner his wife; E. K. Anderson and E. N. Anderson his wife and James Thornton and Elizabeth Thornton his wife, for and in consideration of the sum of five dollars to us in hand paid by the Bank of Ashland, the receipt whereof is hereby acknowledged, have remised released and quitclaimed and by these presents do remise release quitclaim, grant and convey to the said Bank of Ashland all our right title and interest in and to all those certain pieces or parcels of land situate and being in the City of Ashland County of Jackson, State of Oregon, and described as follows to-wit: All of that certain lot or parcel of land beginning at the point of intersection of the North line of Main Street with the East line of Helman Street in said City. Thence South 30° 36' East along Main Street, Thirty-two and five tenths (32.5) feet to the line between lots ten (10) and Eleven (11) in the Ashland Woolen Mills Tract as the same is laid out and subdivided into lots according to the survey and Plat thereof here to attached and made apart hereof. Thence North 59° 24' East along the line between said lots ten (10) and Eleven (11) Eighty-seven (87) feet; Thence North 25° 30' East Sixteen (16) feet; Thence North 30° 36' West Ninety-five and five-tenths (95.5) feet to the East line of Helman Street; Thence along the East line of Helman Street South 25° West one hundred and twenty-three feet to the place of beginning.

Also that certain piece or parcel of land beginning at the North West Corner of said Lot No. ten (10) in said Ashland Woolen Mills Tract on Main Street in said City of Ashland, Thence North 59° 24' East Eighty-seven (87) feet along the line between said lots Ten (10) and Eleven (11); Thence South 27° West, twenty-three and five tenths (23.5) feet. Thence South 60° West sixty-seven and one half (67 1/2) feet to the North line of Main Street; Thence North 30° 36' West Thirteen (13) feet to the place of beginning.

To have and to hold the above described premises with the appurtenances there unto belonging unto the said Bank of Ashland and to its successors and assigns forever.



Know all Men by these presents, that Whereas, we Orlando Coolidge and Mary J. Coolidge, Husband and wife, of the County of Jackson, State of Oregon, being the owners and holders, by an indefeasible, unincumbered title in fee simple, of the following described premises, to-wit: Lot three (3), in Section five (5), Township thirty-nine (39) south, of Range No One (1) East, containing sixteen and 90/100 (16 90/100) Acres, situated in Jackson County, State of Oregon. Did on or about the 6th day of December A.D. 1883 locate and caused to be surveyed on said described land, an Addition to the Town of Ashland, in said County and State, as shown on the annexed Plat of said Addition, and did cause the same to be platted, and whereas, by oversight and mistake the original plat of said Addition to said Town of Ashland, has never been acknowledged and recorded as by law required, and the same is in other respects imperfect, in complete and defective, now, therefore, we the said Orlando Coolidge and Mary J. Coolidge his wife, in order to cure the said omissions and defects in said defective plat, and to provide and secure due, certain, complete and legal evidence of the location of said Addition to the said Town of Ashland, have caused the annexed plat of the Addition to said Town of Ashland, as the same was originally located, and surveyed upon said premises to be made, and we do hereby declare, certify and acknowledge that the same is a true and correct plat of said Additions to the said Town of Ashland as so originally located by us and surveyed upon the said premises.

And that each and everyone of our acts in so locating said Addition to said Town on said premises and causing the same to be surveyed thereon and the said annexed plat thereof to be made, acknowledged and recorded, was and is our free and voluntary act and deed, and that the disposition of said premises as made by said plat was and is in accordance with our wish and desire, and we do hereby dedicate to the use of the public forever, all that portion of said premises designated on said plats as Streets and Alleys.
