A Meeting was held at the Office of G. F. Billings in Ashland Oregon, on the evening of Oct. 20th 1897.

The following named persons were present, Mrs. M. H. Hargadine, Mrs. L. E. Norris, Mrs. Mary E. Casey, G. F. Billings, G. O. Van Satta, Mrs. Armitage, C. A. Carter and Eugene Habrad. A temporary organization was formed by placing G. F. Billings in the chair, and E. Habrad as Clerk, then G. O. Van Satta moved that we form an association to be known as the Hargadine Cemetery Association of Ashland Jackson Co. Oregon. Motion carried.

Moved and second, that we elect one Clerk and three Directors whose term of Office shall be two years, and until their successors are duly elected and qualified. Motion carried. Election of Officers being next in order E. Habrad was placed in nomination for Clerk of the Association, Motion carried, and E. Habrad declared elected Clerk.

Nomination of Directors next in order, Mrs. Mary E. Casey, G. O. Van Satta, and Mrs. Armitage were placed in nomination, and unanimously elected and declared Directors of this Association.

Mrs. Armitage made a motion, that all owners of one or more lots in the Hargadine Cemetery, may at any time before May 1st 1898 become Charter members of this Association, by signing the books of the Association, Motion carried.

It was moved and second, that any person who has paid in full for a lot in the Hargadine Cemetery, shall be entitled to a Deed of the same upon the payment of an additional fifty cents, Motion carried.

Moved to adjourn, second carried.
