DEDICATION

The Subdivision of the Holman Addition to Jacksonville Oregon, and is a part of the NW 1/4 of the SW 1/4 Sec. 32 T. 37 S. R. 2 W. W. M. and is bounded and particularly described to-wit:-

Beginning at the 1/2 S. on line between Secs 31 and 32 Tp 37 S. R. 2 W. W. M. thence N. 89° 30' East 600 feet; thence S. 0° 42' W 432.5 feet; thence S. 23° W. 212 feet; thence S. 89° 30' W 520 feet; ~~thence~~ to section line; thence North 628.5 feet to place of beginning, containing 8.25 acres, excepting land occupied by Jacksonville and Applegate County Road. Multnomah Avenue, the course is North and South, Laurel Street the course is East and West. Multnomah Avenue is 60 feet wide, and Laurel Street is 50 feet wide.

Said Subdivision contains Four Blocks and 42 lots: The Blocks are numbered from 1 to 4 Inclusive, and the lots are numbered from 1 to 12 inclusive, Block 3, 1 to 10 inclusive.

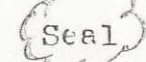
