MAP OF HIGHLAND PARK ADD TO THE CITY OF MEDFORD OREGON Scale 1 in 50 feet (Description)
Beginning at the Northwest corner of Lot 5 in Section 25 Township 37 South of Range 2 West of the Willamette Meridian, and running thence south twelve hundred and no hundredths feet to the southwest corner of Lot 5; thence east five hundred six and eighty eight hundredths (506.88) feet; thence north twelve hundred two and two tenths (1022.02) feet; thence West five hundred six and eighty eight hundredths (506.88) feet to the place of beginning.

(Dedication) Know all men by these presents, that I, Scott V. Davis and Ida H. Davis, (his wife) are the owners in fee simple of the above described land; that we have laid out the same into lots, Blocks, Streets and Alleys as shown by the map hereon, and that said map is a correct representation of said survey and subdivision and we do hereby dedicate to the public for public use as highways all the streets and alleys shown on said tract and we do hereby designate and name the said tract as shown hereon as the Highland Park Addition to the City of Medford.
