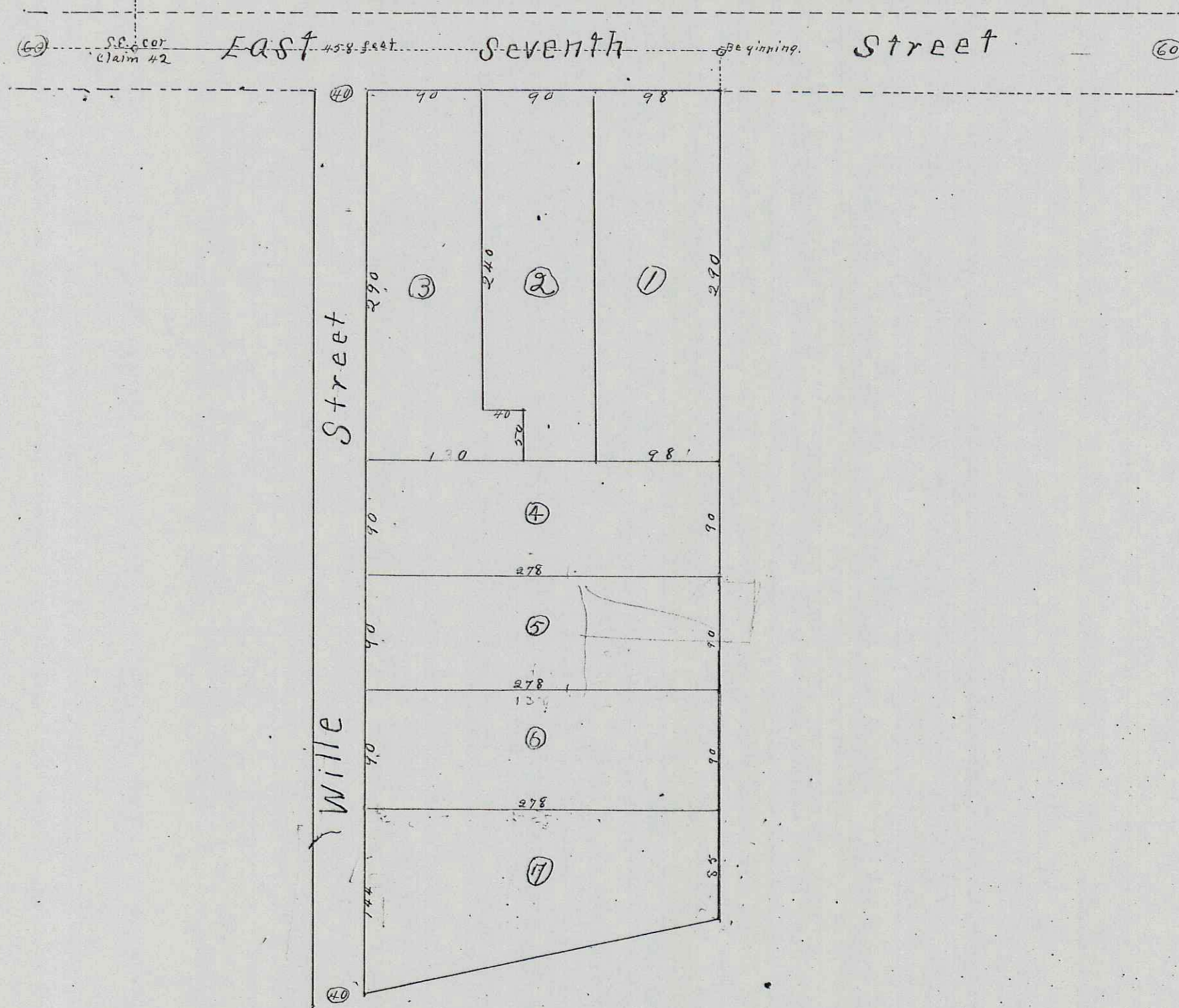


**THE

Jones of Jackson County Oregon do hereby certify that on the 5th day of April A.D. 1906 I surveyed the following described tract of land to-wit: Commencing at a point 24.20 chains west of the north east corner of the P. B. Evans Donation Claim No 44 in Township 37 South, Range 1. West of Willamette Meridian, in Jackson County, Oregon, and running South 20.21 chains, thence S 78° 9' 4.36 chains, thence north 11.12 chains, thence East 4.21 chains to the place of beginning; that I laid out the same out into lots as represented upon the Plat hereto connected; the numbers of said lots are indicated by figures near the center thereof respectively, and the dimensions of said lots are indicated by figures denoting feet near the boundaries thereof.
