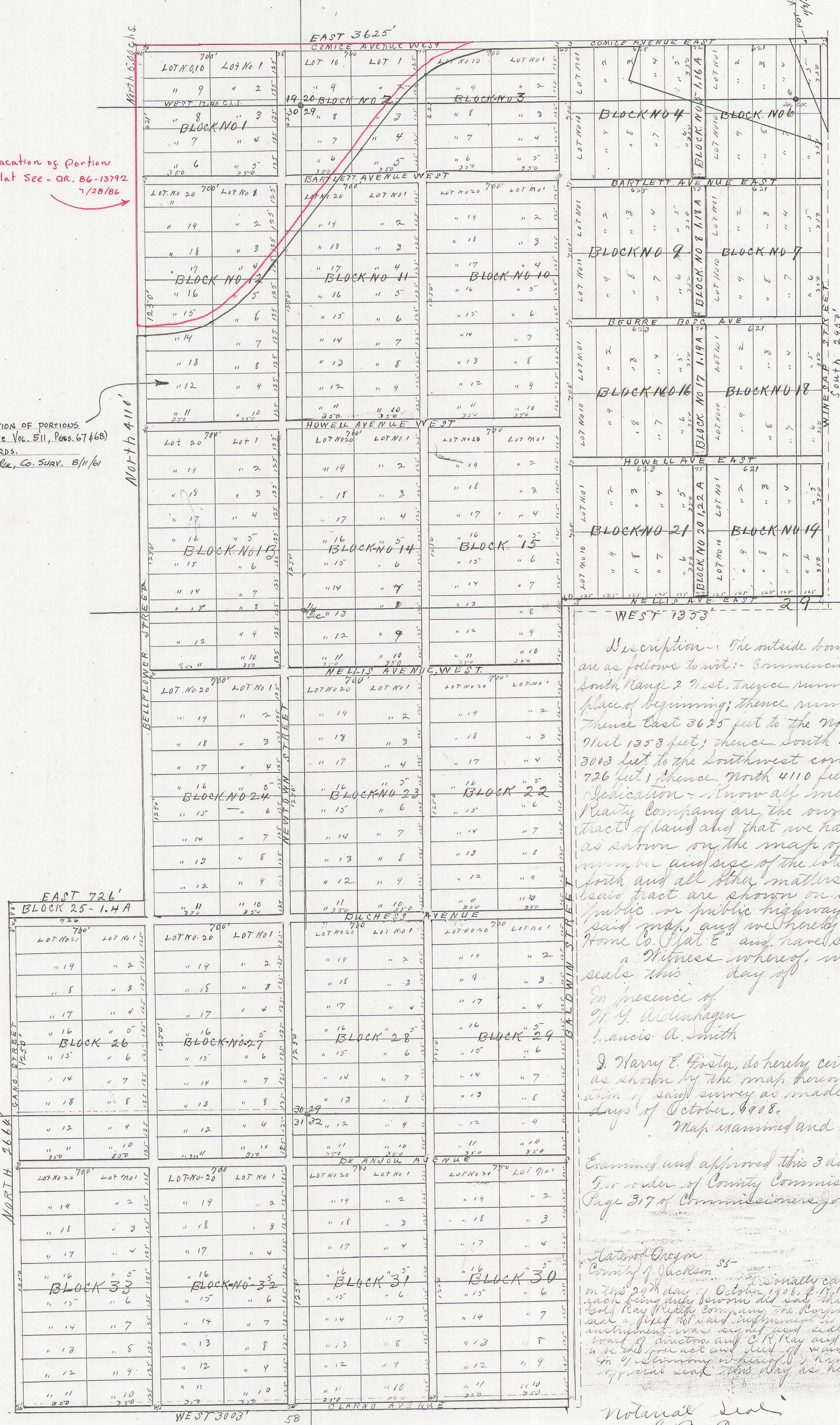

Description - The outside boundaries of the "Orchard Home Co. Plat E" subdivisions are as follows to wit: - Commencing at the S.E. corner of Section 19, Township 36 South Range 2 West, thence running West 818 feet along south of section; to the place of beginning; thence running North 330 feet to the northwest corner; thence East 3625 feet to the northeast corner; thence South 2950 feet; thence West 1353 feet; thence South 4148 feet to the southeast corner; thence West 3003 feet to the southwest corner; thence North 2664 feet; thence East 726 feet; thence North 4110 feet to the place of beginning.

Dedication - Know all men by these presents, that we Gold Ray Realty Company are the owners in fee simple of the above described tract of land and that we have subdivided the same into lots and streets as shown on the map of same, herewith attached, and on which the number and size of the lots and the length of all lines are plainly set forth and all other matters appertaining to the subdivision of the said tract are shown on said map, and we hereby dedicate to the public or public highways all of the streets shown on said map, and we hereby designate said tract as the "Orchard Home Co. Plat E" and have so returned it on the map, hereto.
