

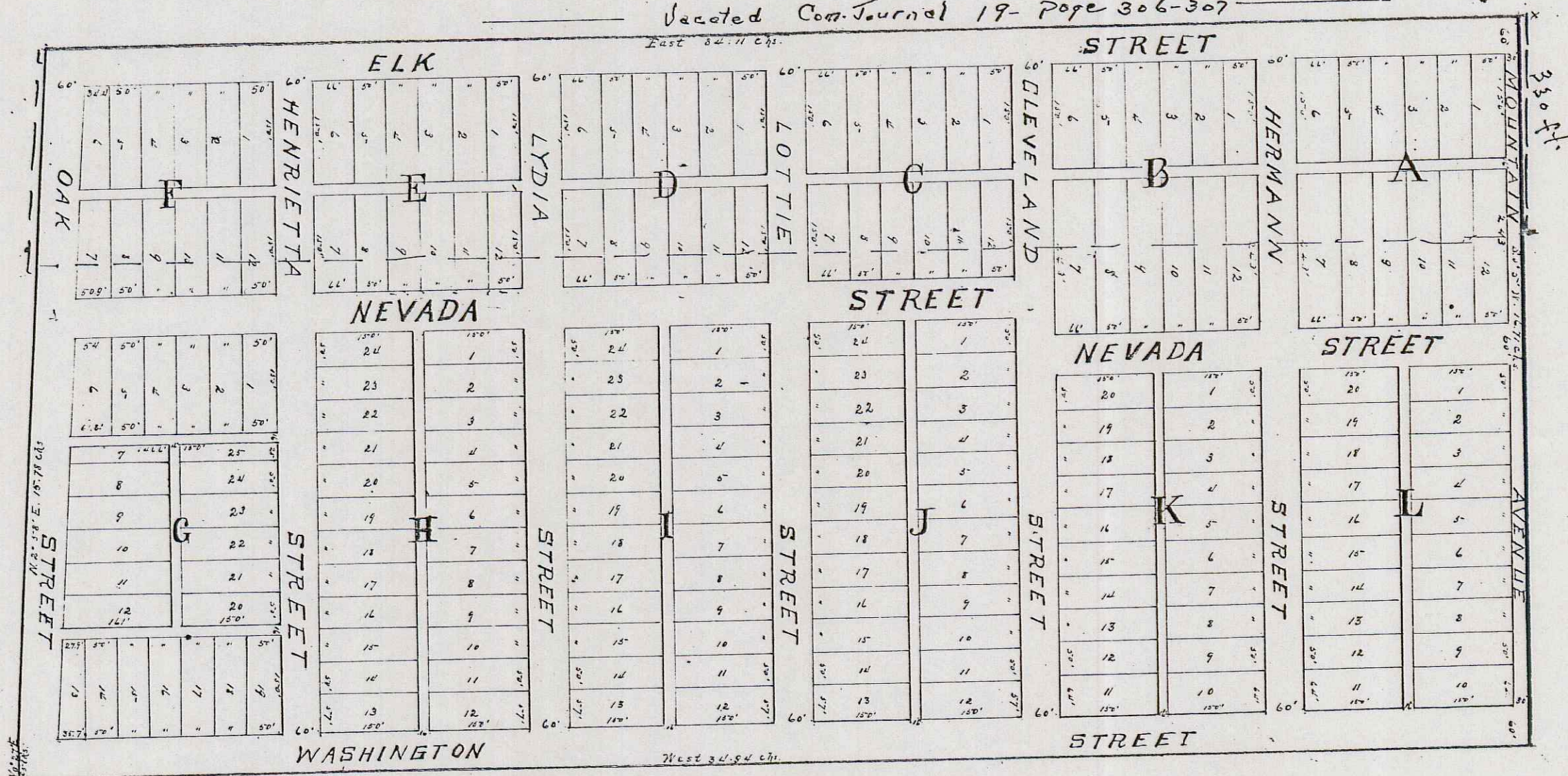
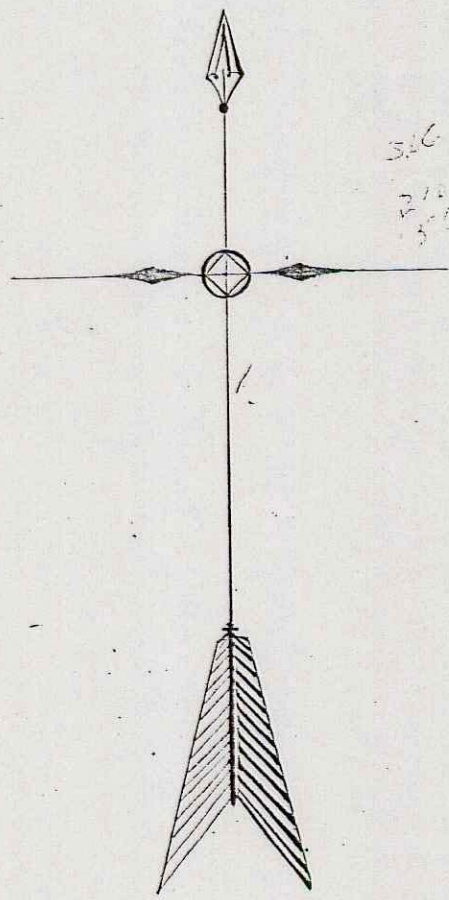

The P. H. & N. Addition to the City of Ashland, Jackson County, State of Oregon, is bounded and described as follows, to-wit: Beginning at a point on the East boundary line of Donation Land Claim No. 41 in Township 39 South, of Range 1 East of the Hillamette Meridian, Oregon; - 39.20 chains North of the South East Corner of the aforesaid claim No. 41; Thence West along the division line between the North and South halves of said claim No. 41 - 52.94 chains to the West line of Oak Street in said City of Ashland, Oregon; Thence along the West line of Oak Street N. 0° 27' E. 95 links, N. 2° 58' E. 15.78 chains; Thence East 52.11 chains to the East boundary of the aforesaid claim No. 41; Thence S. 0° 5' N. along said East boundary 16.71 chains to place of beginning. - Containing 57 1/2 Acres.
