DEDICATION :::

THE PATTISON ADDITION TO THE CITY OF CANTRAL POINT, jackson County, State of Oregon, is a Part of the Southwest quarter of Section 2 and the Southeast quarter of Section 3, Township 37 South of Range 2 West of the Willamette Meridian, Oregon, and is bounded and particularly described as follows, to-wit:-

Beginning at the Southwest corner of Donation Land Claim No. 55, Township 37 South, Range 2 West of the Willamette Meridian, Jackson County, Oregon, thence running North 8.99 chains; thence N. 42° 30' W 10.92 chains; thence West 2.14 chains; thence S. 54° 30' W 3.432 chains; thence S. 35° 30' E 18.40 chains; thence East 1.73 chains, containing 9.76 acres, more or less. Hazel Street, Cherry Street, Maple Street and Laurel Street run N. 54° 30' East and the above named streets are 80 feet wide. Eighth Street is 60 feet wide running N. 35, 30 W which is at right angles to the above named Streets. The dimensions and numbers of Blocks and Lots in said Pattison Addition are as shown on the accompanying map
