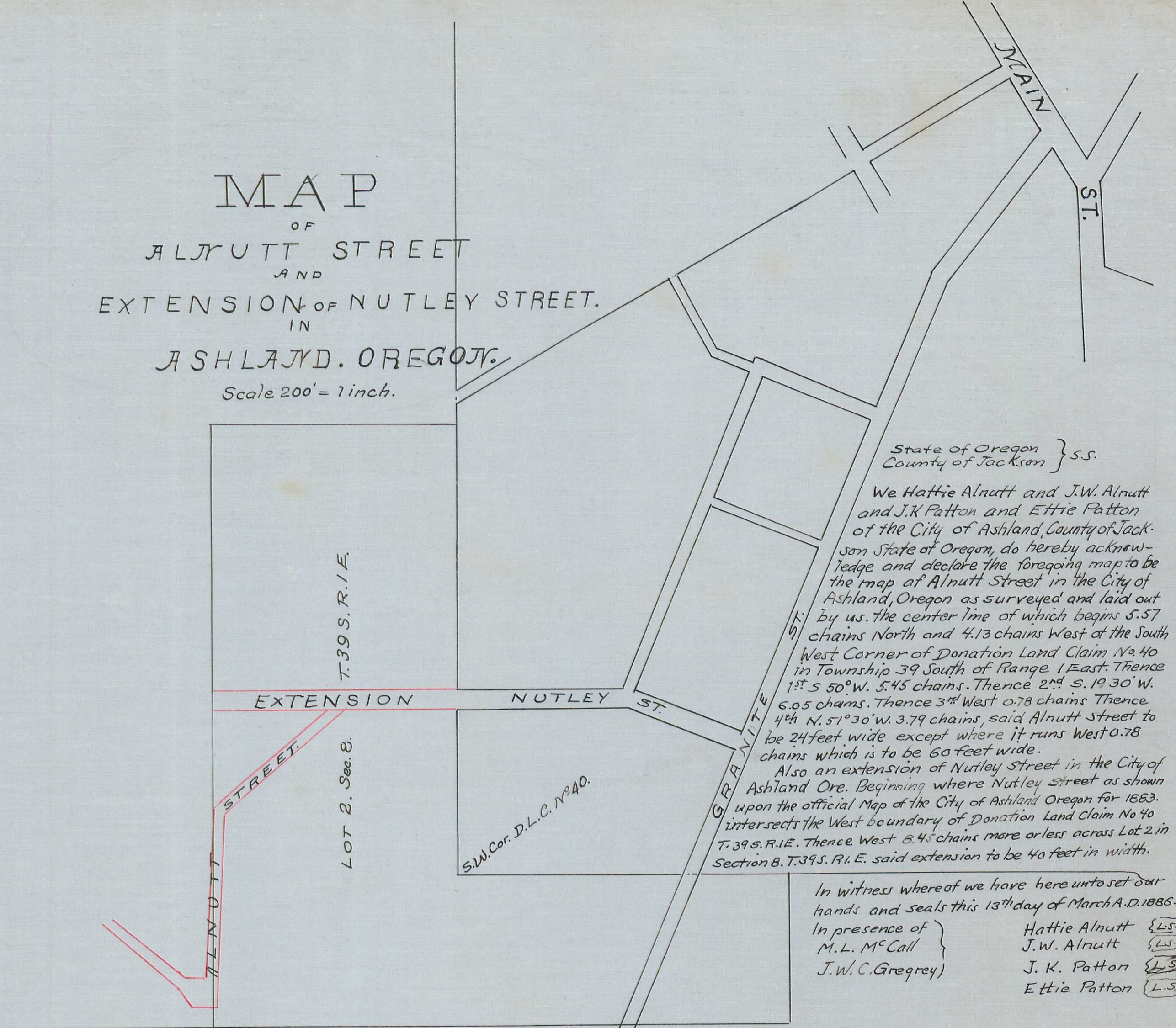

We Hattie Alnutt and J.W. Alnutt and J.K. Patton and Ettie Patton of the City of Ashland, County of Jackson State of Oregon, do hereby acknowledge and declare the foregoing map to be the map of Alnutt Street in the City of Ashland, Oregon as surveyed and laid out by us, the center line of which begins 5.57 chains North and 4.13 chains West of the South West Corner of Donation Land Claim No. 40 in Township 39 South of Range 1 East. Thence 1st S 50° W. 5.45 chains. Thence 2nd S. 19° 30' W. 6.05 chains. Thence 3rd West 0.78 chains Thence 4th N. 51° 30' W. 3.79 chains, said Alnutt Street to be 24 feet wide except where it runs West 0.78 chains which is to be 60 feet wide. Also an extension of Nutley Street in the City of Ashland Ore. Beginning where Nutley Street as shown upon the official Map of the City of Ashland Oregon for 1883, intersects the West boundary of Donation Land Claim No. 40 T. 39 S. R. 1 E. Thence West 8.45 chains more or less across Lot 2 in Section 8, T. 39 S. R. 1 E. said extension to be 40 feet in width.
