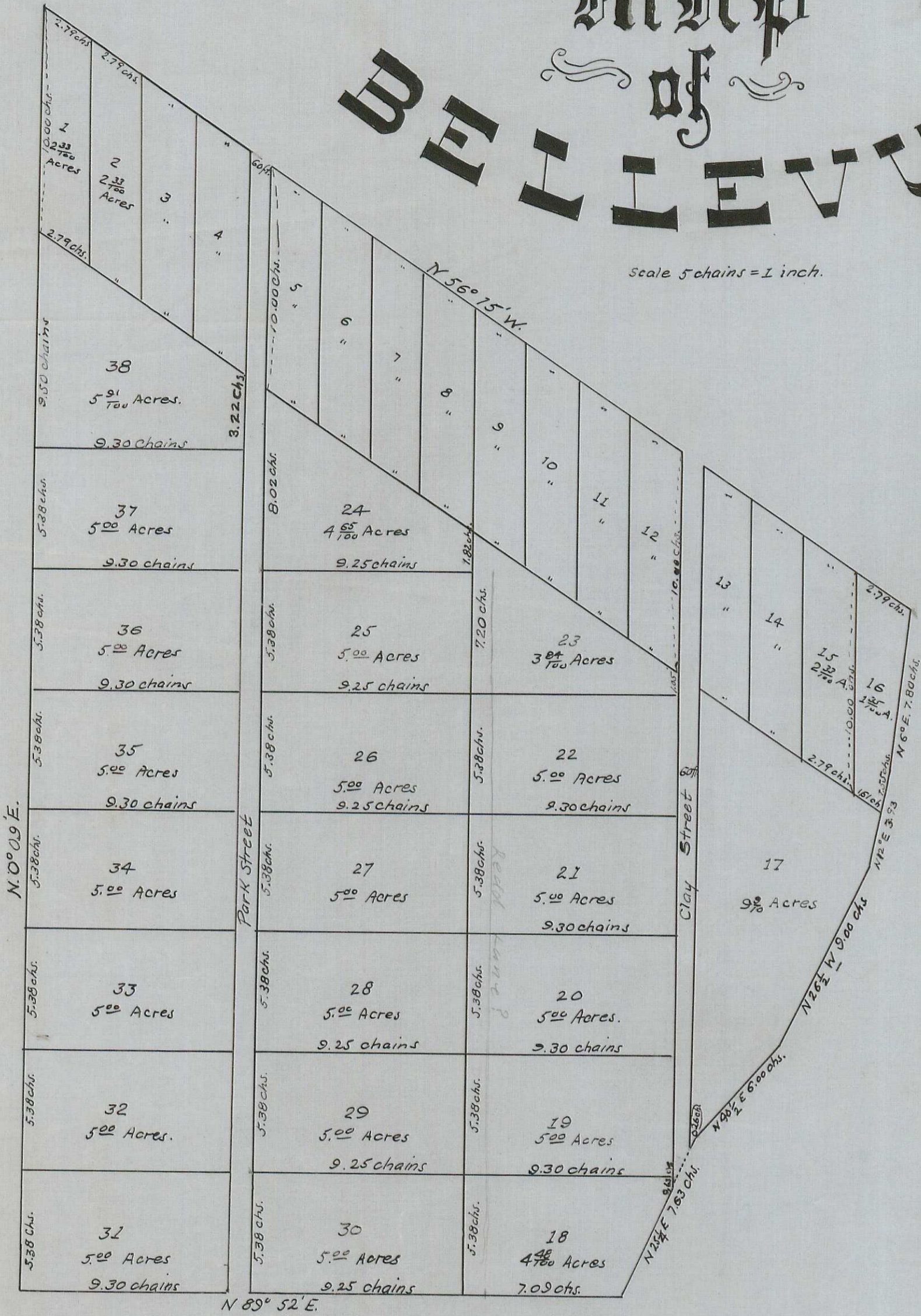


MAP of BELLEVUE

Bellevue is part of Section 14 and 15 in Township 39 South of Range 1 East of the Willamette Meridian, Oregon and is bounded and described as follows to-wit: Beginning at the corner to sections 14, 15, 22 & 23 T. 39, S. R. 1 E. Thence West on line between sections 15 & 22, 20.13 chains to the South West corner to the southeast quarter of the southeast quarter of section 15. Thence North 57.05 chains to the point of intersection of the west boundary line of the Southeast quarter of the Northeast quarter of section 15. With the South side line of the Boulevard. Thence along the South side line of the Boulevard S. 56° 15' E. 44.64 chains to West side Line of Road here to fore deeded by John Derwin to the public. Thence along West sideline of road S. 6° W. 78.0 chains. Thence S. 12° W. 3.83 chs. Thence S. 26 1/2° W. 9.00 chs.
