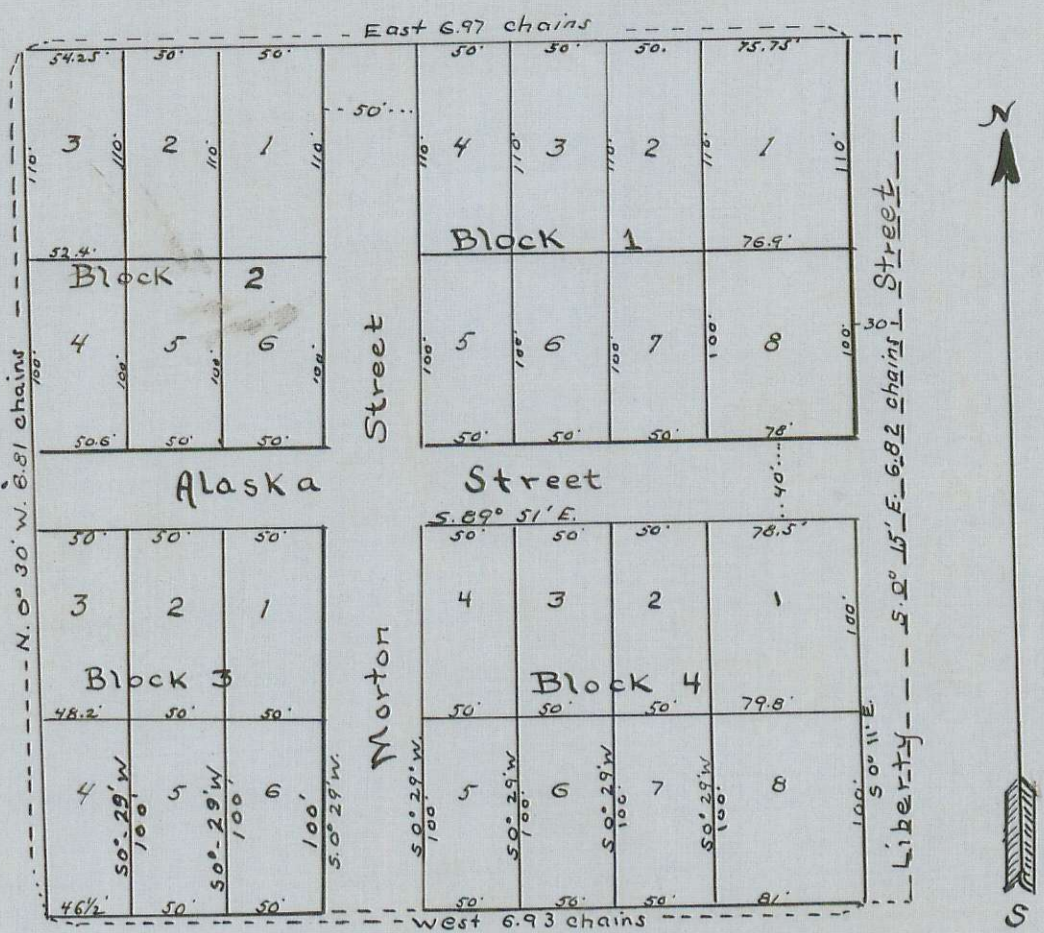


Map of PRACHTS

Prachts Alaska Addition to the City of Ashland Oregon shown above map is a part of lot 4 in section 9 Township 39 South of Range 1 East Willamette Meridian Oregon, and is bounded and described as follows to-wit: Beginning at a point 0.30 chains S.0°15' E. of the North East corner of lot No. 4 in section 9 in Township 39 South of Range 1 East of the Willamette Meridian Oregon, Thence S.0°15' E. 6.82 chains, Thence West 6.93 chains, Thence N.0°30' W. 6.81 chains, Thence East 6.97 chains to place of beginning containing 4.74 acres.

We, Max Pracht and Mary Winings Pracht husband and wife of the County of Jackson State of Oregon, do hereby declare the foregoing map or plat to be the map or plat of Prachts Alaska Addition to the city of Ashland Oregon as above described as was by us who at the time were the owners thereof laid out and subdivided into Four (4) Blocks numbered from 1 to 4 inclusive and said Blocks divided into lots as numbered in figures on said lots. The courses and lengths of the lines of said lots are designated by letters signs and figures upon the boundary lines of said lots. And we do hereby dedicate to the use of the public all streets as shown upon this map.
