THE SOUTHERN HOME TRACT near the City of Ashland, Jackson County, Oregon is bounded and described as follows, to-wit: Beginning at a point on the West boundary line of Donation Land Claim No. 45, in Township 39 South, Range 1 East of the Willamette Meridian, Oregon, from which the Southeast corner of Donation Land Claim No. 39, in said Township and Range, bears North, 870.15 feet distant. Thence South, 771.80 feet to the center line of the Boulevard, Thence N. 56° 13' W., along said center line, 944.50 feet. Thence North 1117.70 feet, to the South boundary line of said Donation Land Claim No. 39. Thence S. 89° 56'E. along said South boundary line, 156.50 feet. Thence S. 35° 49'E., 37.00 feet. Thence South 598.65 feet. Thence S. 89° 56'E., 432.35 feet. Thence S. 35° 49'E., 298.20 feet to the place of beginning. Containing 15.618 Acres.
